

Who's gonna turn on cable?

Boca to state: stop messing around in local business

t's not that Boca Raton Deputy City Manager George Brown doesn't like consumers.

"We just don't want the state messing around in local business," he told *The Boca Raton News*.

Which is why Boca's city council has approved a resolution opposing HB 529 — called the Consumer Choice Act of 2007, a proposed law dealing with what it calls "video programming" but what amounts to what everyone else calls "cable TV." Delray Beach has approved a similar resolution opposing the bill.

HB 529's chief supporter is a group called FreedomWorks. FreedomWorks has mounted a national campaign to change the law and take cable TV franchise power away from local and county governments -- putting it in the hands of the state.

"Under the current law, companies that want to provide video programming are required to apply for a franchise on a town-by-town basis," says FreedomWorks Florida Coordinator Tom Gaitens. "This time-consuming and costly process acts as a barrier to

competition as the application process is expensive and can take years to complete."

Gaitens said this process "does not reflect developments in technology that have allowed phone, wireless, cable, satellite, and other providers to offer consumers choices in video programming options."

HB 529 "allows consumers to take advantage of new technologies by streamlining the franchise application process for potential providers. When companies compete to provide service, consumers win through more choices and lower prices," he said.

Nationwide

FreedomWorks has been involved in trying to change cable TV franchise law in Michigan, North Carolina, Indiana, Kansas, and Texas.

None of which impresses Boca's Deputy City Manager Brown.

Generally, federal law creates a framework by which state and local governments can regulate cable systems. That framework allows state and local governments to create local

franchise au-

thorities (LFA) that license cable operators to provide services in a community. Federal law prohibits an LFA from awarding an exclusive franchise or unreasonably refusing to award an additional competitive franchise within its jurisdiction.

Although LFAs have the authority to grant multiple franchises within a given community, the national trend has been that nearly all local communities have only one cable provider.

Brown doesn't disagree, but says there's a reason for that.

"We only have one (cable TV provider)" he says, "but that's not because we haven't' asked -- literally begged." The market hasn't responded because "they tell us they're not interested in providing that service in this market."

Translated, Brown says, that means cable

Boca Rep applauds felon rights restoration

In what some say is a move that will help to slam shut the revolving criminal justice door, District 90 State Representative Kelly Skidmore (D-Boca Raton) told *The Boca Raton News*, "This marks a milestone in Florida history."

Overcoming the negative vote of State Attorney General Bill McCollum, the Board of Executive Clemency and the Cabinet has voted 3-1 to automatically restore a felon's rights once his or her sentence has been served.

Heretofore, Florida was one of only a handful of states where felons' rights were not immediately restored. However, the new

rule is not without qualifications, Skidmore said. In order for rights to be automatically restored, the following conditions must be met:

- Sentence must have been completed.
- There are no pending criminal charges.
- All victims' restitution has been paid.
- The person has not committed certain severe offenses, or qualifies as a habitual violent offender, violent career criminal or sexual predator.

Among the "severe offenses" are: murder, attempted murder, attempted felony murder, man-

Boca dad: Crossing guards sending wrong message

Victor Dell-Isola takes his job seriously.

Each weekday morning and afternoon, he puts on his yellow and orange vest and directs a group of backpack strapped youngsters across Palmetto Park Road and 12th Avenue in Boca Raton.

As a crossing guard for the city of Boca Raton, Dell-Isola prides himself on keeping children safe on the way to and from school.

For Dell-Isola that means waiting until the light signals that it's safe to walk across the

"We always wait for that crossing signal to come up before we cross a child. Otherwise it's not safe," said Dell-Isola, who's worked as a crossing guard on

that corner with three others since January.

However, Boca father Mike Bacarella says otherwise.

Dropping off and picking up his three children at various Boca schools, Bacarella said he's observed crossing guards walking children across the street when the stoplight signals not to walk. The local father said he's seen this occur at Palmetto and 12th Avenue, Camino Real and 12th Ave, and Glades and Dixie Highway, among others.

"I see it all the time. Why can't they wait for the right sign and walk our kids across the street then? It only takes a minute," he said. "It seems to me we are programming our children every day to walk across the street when it's unsafe. Every single day they walk to school

and everyday they are taught to walk when it says not to. Why can't the crossing guards walk our children across at the proper time when the sign says it is okay to walk?"

Bacarella is worried the crossing guards may program children to walk across the street at the wrong time and in turn cause an accident.

"It will eventually be second nature to the children to just walk across the street when it says not to," he said. "Now is the time to correct this problem before someone gets hurt or killed."

The father further believes that

proper training is necessary. "Whoever is in charge of crossing guards should give

Andre Davies of Boca Raton has experienced both.


Most recently, the local student experienced the benefits.

Boca Raton police are investigating recent daytime residential burglaries that have occurred in the western part of the city between St. Andrews Boulevard and Powerline Road

Police spokesman Sgt. Eric

Community policing station lease in West Boca extended one year

County commissioners have extended the lease of a community policing station in West Boca Raton.

An agreement with the Jewish Federation of South Palm Beach County, Richard and Carole Siemens Jewish Campus for use of a 1,770 sq. ft. building located at 9378 SW 210th Street in Boca Raton has been extended through May 2008, commissioners said. The three-year lease began in 2004, with two, one-year extension options.

The annual lease cost is \$10; however the lease prohibits use of the building for the holding of detainees, the use as a transfer site for persons under arrest, or as a building used by persons on a work release program.

The agreement also provides for the county to pay for all utility costs, commissioners said.

Other Business

In other recent business commissioners:

- Approved a \$159,885 contract with Lanzo Lining Services, Inc., for the construction of Loxahatchee River Road and Eagle's Nest Drive culvert improvements. The work will include lining the existing culverts under both roads with flexible pipe, commissioners said.
- Amended an agreement with the State of Florida Department of Transportation (FDOT) to add \$17.4 million in Transportation Regional Incentive Program (TRIP) funds to the agreement. The money will be used for wid-

ening and resurfacing improvements on SR-704/Okeechobee Boulevard from west of SR-7 to east of Jog Road. This makes a total of \$23.9 million committed to that project, commissioners

- Approved an agreement with Seacoast Utility Authority for release of Seacoast's interests in a parcel of land required for a right turn lane on Military Trail. Commissioners said the agreement requires the county to pay for any future relocation costs of the utility facilities when and if requested by the county.
- Adopted a resolution to authorizing the filing of eminent domain proceedings against one parcel whose total appraised value is \$7,000. The land is needed for the improvement of the intersection of Gateway Boulevard and Congress Avenue, commissioners
- Approved spending \$88,000 to install speed reduction humps on Edgehill Road, Upland Way and Westchester Drive in District
- Approved a Joint Project Participation Agreement (JPA) with the City of West Palm Beach for the construction of an emergency mast arm traffic signal at the intersection of Broadway Avenue (SR 5/US 1) and 49th Street. The city has built and currently operates a fire station on the corner of the intersection, and will pay \$350,000 to the county for the

slaughter, DUI manslaughter, sexual battery, attempted sexual battery, sexual performance by a child, aggravated child abuse, transmission of computer pornography, buying or selling of minors, kidnapping, attempted kidnapping, false imprisonment, luring or enticing a child, aggravated battery, attempted aggravated battery, armed robbery, attempted armed robbery, carjacking, attempted carjacking, home invasion, attempted home invasion, poisoning of food or water, abuse of a dead human body, first-degree burglary, attempted first-degree burglary, arson or attempted arson, aggravated assault, aggravated stalking, aggravated battery or aggravated assault on law enforcement officer, first-degree trafficking in illegal substances, aircraft piracy, unlawful throwing, placing or discharging of destructive device or bomb, facilitating terrorism.

Skidmore said the rights being restored include the right to vote, serve on a jury, apply for occupational licenses and the ability to hold public office. The right to own a firearm, however, will not be restored under this new ruling, Skidmore said.

"This is indeed an historic moment for Florida," said Skidmore. "Many legislators have worked tirelessly for years and years to achieve automatic restoration of civil rights. With today's support of the Governor and Cabinet, their relentlessness has finally paid off."

Randy Berg, executive director of the Florida Justice Institute in Miami told the Boca Raton News: "People need to have their civil rights restored immediately after prison so they can get decent jobs, earn a living, support their families and pay taxes. If they can't, it can very quickly become a self-fulfilling prophesy of going back to what they know --- a life of crime."

Nationwide, some 1.4 million ex-felons in 13 states are prohibited from voting --- and Florida heretofore led the nation in the number of ex-felons who don't get civil rights restored, according to Berg. "Only 15 percent get rights restored," he said, and that leaves about 700,000 without civil rights."

Sitting on the board that made the decision, Governor Charlie Crist said after the vote: "I believe in simple, human justice -- "when someone pays their debt to society, it is paid in full. There is a time to move on."

Boca Raton has pretty much nailed down a site for a proposed ice skating rink.

The next step is to find someone to build it.

That process will begin in earnest shortly when the city advertises a "request for proposals (RFP)" to build the rink on municipally owned land in the developing de Hoernle Park off Spanish River Boulevard.

City Council members on Monday gave City Manager Leif Ahnell the green light to find a builder.

Status report

The action followed a presentation by Recreation Services Director Mickey Gomez, who updated the council on the status of the rink that has been in the discussion stages since last summer.

Gomez said he could issue the RFP within two weeks. Ahnell said the city will put up the land; a private company will do the construction.

The recreation services director said plans call for one or more buildings totaling about 90,000 square feet to house two National Hockey League-sized rinks and possibly a third Olympic-sized rink.

Plans also call for a parking lot that will accommodate up to 400 cars, seating capacities of 400 to 2,000 people, a fitness room, skate-changing area, four team locker rooms, sports medicine room and a shop to sell figure skating and hockey equipment.

City officials said they would like to add an enclosed children's play area, heated rink-side seating and wireless Internet capacity.



Perks for city

Ahnell said the city would not operate the rink, but the entity that does must set aside ice time for city programs and give residents priority registration and a 15 percent discount. Also, the city may get a piece of the profit.

Councilman Bill Hager asked if the Greater Boca Raton Beach & Park District would work with the city on the rink in any fashion. Ahnell said he would ask them in a letter, but Gomez said the district "has a lot on its plate."

He said it will take about three months for bids to be processed. A decision may be made by the end of the year.



them a lesson on safety," he said. "Or is this how they are training them? "Like anything else, they wait until a kid gets crippled or killed before they change it."

But Dell-Isola insists that at least for himself, he always crosses when the light says its appropriate to do so. He says crossing guards are put through training before being put on the job. This training includes watching films, onsite training and frequent checks from supervisors to make sure the guards are doing the job correctly.

"We were taught never to cross the children until we see the crossing walk sign. It's not something that's taken lightly," he said. "The parents have entrusted me with the safety of their children and if I made a mistake I wouldn't be able to live with it."

I think I have a good but unusual problem. In late 2002, I wrote and told you that my wife and I sold our buge home in Durham, N.C., because our children are gone and married. We sold that bome and moved into a much smaller but very comfortable new home. After buying the smaller home we had \$83,000 in cash remaining. Our only stock market experience is about \$101,000 in some utility stocks that have done very well over the past 30 years we've owned them because we have reinvested all the dividends. When we asked you what to do with \$83,000, you advised us to put it into an Equitable variable annuity because we did not want any risk, because it guaranteed to pay us 6 percent on our \$83,000 investment, because it was tax-deferred, because Equitable would guarantee our \$83,000 death benefit no matter how bad the market performed and because it would increase in value if the market did. Well, all those things happened and our variable annuity after three years and four months is worth \$142,000. And we are very grateful for your wise advice.

Now here's our worry. What if the stock market gets weak and the Dow Jones falls by 10 percent or 25 percent? The value of our investment could easily go back to the guaranteed \$83,000 and we'd be back right where we started. But if we sell it before the contract period ends (like today) we will have to pay ordinary income tax on a \$59,000 gain plus a 6 percent "early-out" penalty fee to Equitable based on our \$83,000 investment. So what do we do to protect ourselves? Sell the annuity and pay the taxes or continue to hold it and hope the market doesn't fall? And at our ages (70 and 72) we are concerned that we may not have enough time to ride it out. But we would like to preserve and guarantee our

\$59,000 gain. How can we do

Dear G.T.:

You've asked a question that's extremely important to many investors who own Equitable and other variable annuities. And while I'd like to believe that the market will continue its uninterrupted upward momentum, I'd be a fool and a blithering idiot if I did.

Oh, I think the market will continue higher. In fact I'm convinced that it will continue much higher and that the Dow Jones Industrial Averages could exceed 25.000 in the next dozen years or so. And 25,000 is not much of a stretch because that gain represents a 6 percent average annual compounded return over the coming dozen years. However, between now and then, it's quite likely that there will be some serious declines and those declines (possibly in the neighborhood of 2,000 or 3,000 points) will be mighty scary. I guarantee it! And in the process many investors will get a severe dose of the megrims, the fantods and perhaps serious case of PSMD (post-stock market

But you're right as a rain: the value of your Equitable annuity could fall back to \$83,000 and you will have lost all your gain. And you're also right as a rainbow: if you liquidate your annuity you will have to pay ordinary income taxes on your gain plus a 6 percent "early-out" (before the eight-year contract period ends) penalty.

But there's a solution and it's called a "1035" exchange transfer to another variable annuity which will accomplish five objectives and put you way ahead of the curve ball. So:

1. The 1035 transfer allows you to move a low-cost basis annuity to another insurance company and avoid federal income taxes on the gain in value. So if you move your Equitable annuity worth \$142,000 to (for example) MetLife's variable annuity there



will be zero tax consequences.

2. You will then lock in a new \$142,000 market value "living benefit," which with MetLife steps up every year. Your old Equitable living benefit never steps up but its death benefit (to the beneficiary) does every five years.

3. MetLife will guarantee you 6 percent income on \$142,000 or \$8,520 vs. Equitable guarantee of 6 percent income on \$83,000 or \$4,980 and which is a \$3,540 difference.

4. MetLife will credit you a 5 percent signing bonus on \$142,000 or \$7,100, which will nullify the 6 percent "early-out" penalty of \$4,980 that you must give up to Equitable.

5. While your living benefit with Equitable will always be \$83,000, your living benefit with MetLife (which never decreases) will increase every year as the market value rises. So if the MetLife policy grows to \$160,000 next year your new "lock-in" living benefit is \$160,000 and MetLife guarantees you 6 percent income on \$160,000 or \$9,600. And it can never be less.

This 1035 exchange solves your problem. It locks in the higher market value for your living benefit. The higher value is locked in very year and the 6 percent income guarantee will always be based on the higher value even if the stock market falls 10 percent or 25 percent. And that's a humdinger deal.

Temple Beth El to put 'sacred space' in West Boca

CITY EDITOR Temple Beth El of Boca Raton wants to "put a sacred space" in West Boca, said Senior Rabbi

Dan Levin. With that in mind, the synagogue is moving ahead with plans to build a religious school, a pre-school and a community center at the corner of U.S. 441 and Yamato Road.

The largest synagogue in Boca Raton, Temple Beth El is under contract to purchase the land from a developer who is buying the parcel from the county. That developer plans to construct a commercial plaza, a group home for the Jewish Association for Residential Care (JARC) and the Temple Beth El project.

"We would love to start con-

struction," he said. "Hopefully, we can begin early next year and complete it within the year," the rabbi told the Boca Raton

The temple began several years ago to look westward. Initially, it acquired a piece of land near Loggers Run, but it was not exactly what the synagogue wanted. "It was a little too far south," said Rabbi Levin.

The synagogue even began working with an architect, and filing zoning proposals with the county for the Loggers Run area plot of land.

Rabbi Levin said Temple Beth El learned about a development at 441 and Yamato, but that builder was dealing with another Iewish school.

The deal apparently didn't

work, and Temple Beth El stepped in. It contracted to use the Yamato-441 parcel, withdrew its zoning requests and sold the other property.

The rabbi said the new facility will reach out to the enlarging western community where many Jews reside. However, the temple on Fourth Avenue will remain the focus of services for the congregation.

He said special services may be held occasionally in the western facility.

Plans say the new center will include 10 pre-school classrooms, 10 religious education classes and a multi-purpose

Good soil helps good landscape

Fourth in a Series

Good soils improve the health of everything you plant and make your landscape less vulnerable to pests. More importantly during a drought, rich soil will help hold moisture and reduce the need for watering.

Because water percolates through sand very quickly, experts recommend enriching South Florida's sandy soils with composted plant debris and/or peat.

These additives (called amendments) are mixed into the soil several inches deep. The best ones are organic - sphagnum peat, wood chips, grass clippings, leaves, straw, compost, biosolids, sawdust and wood ash.*

Compost is a wonder worker for gardens. It's absolutely free and will keep your plants healthier... especially during droughts.

Composing is simply speeding up the process of decomposition of organic matter. For best results, mix materials high in

nitrogen (fresh grass clippings, kitchen scraps) with those high in carbon (dried leaves, shredded wood and newspapers).

While a bin will help contain a compost pile, it is not necessary. You can choose an inconspicuous, well-drained spot in your garden, cover it with shredded newspaper and then pile on leaves, grass clippings, straw, woody brush, vegetable and fruit scraps, coffee grounds, eggshells and/or sawdust. Note: Do not use diseased plants that will spread the disease, meat scraps that may attract animals or pet manure that can carry disease.

The beauty of composting is that you simply let decomposing organisms like worms, fungi and bacteria do their thing. If you turn your pile every day or two, you should get compost in less than four weeks. In case it looks dry, sprinkle a little water on your pile. Finished compost will smell sweet and be cool and crumbly to the touch.



You can work compost into the soil around any new plants that you're installing in your landscape; it will help hold moisture even after the 30-day establishment period which allows you extra watering for new plantings..

*Note: Using newly chipped wood, vermiculite, perlite, tire chunks or pea gravel is not recommended.

TV operators want to cherry pick TV franchise powers away from lothe market. "We want service throughout the city, or on some reasonable build out schedule, but they only want certain communities that are more appealing in terms of customers."

But Brown adds there's an even bigger problem with taking cable

cal government.

"It takes away a local government's control of its own rights of way," he says, and the state could then issue a franchise to string up wire in a city right of way." The city would lose control over potential property damage and "aesthetic" issues, Brown says.

Another problem, Brown says, "is that these businesses in turn are using these rights of way to make money." And with the city controlling the franchise, "in exchange for the privilege of making money off a public asset, the city gets something in exchange."

And that is not necessarily money, Brown says. The most im-

portant thing the city gets is that citizens have local access to the provider.

Not so under HB 529. Under the proposed legislation, customer complaints would have to be filed with the Department of Agriculture and Consumer Services. This would include "service or billing issues," he says, and would

include larger policy type complaints. "All would have to be filed in Tallahassee."

"Let's be realistic," he adds, "if someone is not getting service anyway, they're going to call the city, but then we won't have any authority to act upon them."

But in general, Brown says, the question comes down to "home

rule."

"We don't want the state messing around in local business," he repeats, adding that even the ability for the city to negotiate with a provider for a local government channel, "would go away."

Which is what Brown would like to happen with HB 529.

Lynn students elect new SGA officers; select second consecutive president from Congo

Fleeing from a war erupting in the Democratic Republic of Congo, watching rebels kidnap his father, and seeking refuge in an unknown land may appear to overshadow Bernard Londoni's recent presidential win for the Student Government Association (SGA) at Lynn University in Boca Raton.

But instead his struggles will strengthen his term as SGA President where Londoni said he'd use his experiences to push for international and all students' rights.

"My motive to run for office was to see how to improve student services on campus and mostly the passion I have for helping students," Londoni said. "I want students to have the very best services on campus. I want to represent students on all levels when they have a problem with administration, faculty or staff members."

The 2,700-student campus recently elected Londoni, its second consecutive SGA president from the Democratic Republic of Congo. Last year's SGA president was Fiston Kahindo.

Londoni, a sophomore majoring in international relations and ness, will be joined by a diverse cabinet including: Vice President Armando Castillo, a sophomore from Guatemala, Chief Financial Officer Michael Griffith, Secretary Gene Prousnitzer, Knights Activity Team Chair Joey McNamara, and Residence Hall Association Chair Lynette Hidalgo. The newly elected officers will officially take the reins April 24.

With the new leaders, Londoni said he would push for more scholarship opportunities for economically challenged students, increase student services on campus, and identify those services and then pass the needs on to administrators.

"I will take the time to talk to as many students one-on-one as possible to find out what they need and want," he said.

However, Londoni admits he will never forget his past. Growing up in Eastern Congo with his mother, father, two sisters and brothers, Londoni said he was living a normal life until the war broke out in his town of Eastern Congo. Londoni said he was 17 at the time.

"We heard gun fire and even saw how people were killed when we were running. It was dangerous. We hid in a bush," he said.

The next day, Londoni and his minoring in international busi- family returned home but all was not safe. The rebels began searching homes looking for those who did not support them. Londoni's

father, who was a church leader, was kidnapped.

"We assumed he was killed,"

Filled with grief and fear, Londoni and the rest of his family fled to Harare, Zimbabwe. While working at the American Embassy, a college fair changed his direction. He received a scholarship to Lynn University in Boca Raton. A smaller campus and a more diverse international population also influenced his decision.

With his most recent presidential win, Londoni said he would advocate for student needs. He hopes to host an event on campus where international students can educate others about culture.




