

City manager says \$75,000 to brand Boca

Boca Raton City Manager Leif Ahnell said the cost of creating a "branding" campaign for Boca Raton "would be about \$75,000." "This, of course, does not include the costs of implementation or marketing the brand," Ahnell recently told the City

It appears future discussion of the branding effort launched nearly a year ago by City Councilman Peter Baronoff will be

Those who support the proposal - and those who don't seem to agree that goal-setting is the right place for continuing talk about the program.

Pet food recall underway

Boca vet urges only dry food.

Boca Raton veterinarian Dr. Lisa Singer has had "one sick animal that I know of, and a second one that is doing better by herself now" following apparent ingestion of food now being recalled by a major supplier of dog and cat food in North America.

"We're recommending feeding only dry food at this time," Dr. Singer told *The Boca Raton*

In 2007, Menu Foods was expected to produce more than a billion containers of dog and cat food. Consumers, however, will not be able to buy all of them because the Canadian based firm has recalled containers manufactured between December 3, 2006 and March 6, 2007. A total of 40 brands of cat food, and 51 brands of dog



food are being recalled.

The recall has been called by the death of 10 animals in the US, and a variety of illnesses, all related to renal health, the firm said. The company said the deaths and illness coincided with the use of a new ingredient, which has been discontinued. Menu estimates the recall will cost \$30 million to \$40 million; the fund value itself dropped 25 percent early this week.

Dr. Singer operates Boca East Animal Hospitals, and signs to watch for she said, are "if your pet has been listless, vomiting, or has diarrhea."

If any of those symptoms are present, "see the vet," she said.

The animal would then receive "blood work and urinalysis to determine proper kidney function," she said.

The recall is limited to "cuts and gravy" style pet food in cans and pouches manufactured at two of the Menu Fund's US facilities. These products are both manufactured and sold under private-label and are contract-manufactured for some national brands.

Construction at long-overdue Boca library about to start again

The rumble of heavy equipment and the clatter of workmen with tools will soon be heard again at the site of the new western library on Spanish River Boulevard in Boca Raton.

The city has brought in Boca Raton-based Kaufman Lynn to complete the building that is about 70 percent finished, said City Manager Leif Ahnell. The parcel has been empty - except for a Boca Raton police officer guarding the lot - for nearly a year.

Ahnell told the City Council that Kaufman Lynn was to be on site starting Monday.

Assistant City Manager Mike Woika said it may be a while before work crews are visible. "One of the first things they have to do is fix the roof," he said. "A lot of the inside work cannot be done until the roofers are finished."

A meeting with roofers was to be held this week.

Building stopped

The project was halted last March after the previous contractor. South Florida Construction Services (SFCS), sued Boca Raton, claiming the city had withheld payments and refused to grant an extension of time for completion of the building. The owner of the company told the *Boca Raton* News he was refused additional ricanes of 2004 and 2005.

Jerry Gilman, owner of SFCS, said his firm would be willing to return and finish the project at a lower cost than Kaufman Lynn. But city officials say they have had no contact with SFCS in months.

As to the cost, Ahnell said Kaufman Lynn will receive \$5.7 million for the work -- \$2.2 million to cover what remains undone and \$3.5 million to complete the job.

December opening

The city manager said the building should be finished by October, but staffing and equipping it will take a couple of months. He is anticipating "a grand opening" in December.

Ahnell has not put a total on the amount the delay is costing the city. He did say the \$2.5 million in last year's city budget -- allocated for the operation of the library – will be used instead to cover the expected additional costs from the lawsuit and the delay.

The city awarded the contract to SFCS, the low bidder, on Jan. 27, 2004. "The original contract completion time was 420 days for substantial completion and 450 days for final completion from the notice to proceed," said Ahnell. He said that notice was issued on July 7, 2004.

Superintendent warns parents of cyber bullying

Technology has a vicious side.

That is, if it's in the hands of a teen bully.

Nowadays, teens no longer bully others through hitting or trash talking. Instead what many see at the cowardly route is taken: fingers doing the ridiculing by sending vicious rumors via text messages and on-line networking sites such as MySpace.com.

Unfortunately with just one click of a button, teen bullies can send mass derogatory emails to thousands of strangers- taking bullying to the extreme.

Thus, the term cyber bullying was coined and with technology at teens' fingertips it's rapidly spreading across schools nationwide and throughout Boca Ra-

In a past Boca Raton News article an unidentified 13-yearold girl attending a Boca middle school said she was tormented at school by a classmate, screamed at in the school lunchroom, given nasty looks in the hallways and had basketballs thrown at her during P.E. that left bruises on her legs. As for cyber bullying, she said the classmate would post hate bulletins on MySpace and AOL Instant messenger calling her "fat" and send derogatory text messages.

And this girl isn't alone. A recent study shows that students at all grade levels, including 90 percent of middle school students, are being bullied in emails, through cell phone, text messages, or online sites such as MySpace and Face Book. The study shows that only 15 percent of all parents even know about cyber bullying. Worse, fewer parents know children are victims because the children too often are embarrassed to tell them or teachers.

After seeing these alarming statistics, the School District of Palm Beach County decided to take action. County School Board members recently agreed to lobby for a change in state law, allowing districts to ban cell phones on school grounds citing growing cyber bullying through belittling text messages and indecent pho-

Call to parents

Most recently, Superintendent Dr. Art Johnson sent a 90-second phone message on cyber bullying to inform county parents.

"I am calling to alert you to a situation becoming increasingly more dangerous for our teenagers, and to ask for your help," Johnson said. "Parents, this is a dangerous situation. Immediate action must be taken. Bullying can lead to violence."

Johnson's tips cited from experts include:

Monitor all Internet sites being visited by children, particularly late at night.

your exiting grout to its original beauty!

Talk to children to break this cycle of teen cynicism in which they think we adults don't know or care enough to help them.

- Tell children not to respond when they are bullied online, and to not talk about e-mail conversations at school.
- Tell them to not share computer passwords and regularly change them.

"Parents, we must act or the cyber bullying will get worse. We must stop it from hurting our children and disrupting their education when they bring these issues to school," Johnson said.

Johnson's call out was directed to parents, but some local teens said they didn't know about or the severity of cyber bullying.

"I was kind of surprised. I didn't think people were bullying other people on-line and through MySpace," said Boca teen Ashley Poltrock.

Once Poltrock heard the message she asked her friends about cyber bullying and found that some were on the receiving end.

"Last week one of my friends told me that she were getting emails on MySpace saying she was fat and then on instant messenger saying she was fat, ugly and calling her names," Poltrock said. "It's sad to hear that kids would bully other kids. It makes no sense to me."

that Baronoff brought branding to the floor. Most resistant to the proposal was Mayor Steven Abrams, who still hasn't warmed up to the plan.

But Baronoff is doing his homework. He held a meeting Jan. 24 for a community-wide discussion of branding - that is, establishing a marketing plan for the city. He, Deputy Mayor Susan Whelchel and Councilmen Bill Hager and M.J. "Mike" Arts showed up, but the mayor didn't.

Those in attendance saw a presentation by Samara Hughes, marketing director for North Star Destination Strategies, about how the firm has helped other communities develop branding strategies.

In her presentation, Hughes said it was important to determine if Boca "wants to speak in one voice." She said marketing a city "is more than just a logo or a slogan. Branding is what people say about you when you are not around."

Abrams said he feels Boca already has a national and international reputation that will not be helped by monogrammed t-shirts and hats.

In a memo recapping the Jan. 24 meeting, Ahnell said "the majority of the comments from the attendees supported initiating a branding effort in the city – and most agreed that it would be successful."

"The dissenting opinion is that the city already enjoys a branding or reputation and does not need a branding process to bring additional residents, visitors, development, new or commercial facilities to the city."

If Boca does decide at the goal-setting session to go ahead with the branding effort, Ahnell said he wants to hire a consultant. A determination will have to be made for funding, he said.

Whelchel also has another idea in mind. She suggested at a recent council meeting that ideas for a "brand" could be the subject of a contest among local school children.



Omni Middle parents upset over school bus running late, overcrowded; affecting FCAT

On a typical bus ride to Omni Middle School, students can expect squeezing into a seat, standing, waiting an hour, or arriving late to school, according to Boca parents.

"The biggest problem is they go to the bus stop at 8:20 and sometimes it doesn't show up until 9:10. School starts at 9:25. And what's worse is a lot of kids don't think the bus is going to show up and they go home and don't go to school," said Boca mom Tammy Waronicki, whose son rides the bus to Omni Middle.

For Waronicki's son, the bus is his only ride to school.

"We live several miles from school and I have to work so if he wants to get to school he has to ride the bus," she said.

Waronicki isn't alone. About thirty other Omni Middle parents wrote letters to the district expressing concern over the bus situation. Omni Parent Teacher Student Association (PTSA) sent an email asking parents to send letters.

"It has come to our attention that there have been some issues regarding bus transportation to and from Omni Middle School. As a voice to assist and encourage parent and public involvement in our school, we would like to try to help with this issue. If you have a bus issue with your child; whether it is safety, overcrowding, drivers, or anything else that you feel is important, we need to hear from you," the email stated.

Those 30 letters were sent to the district, according to Omni PTSA President Debbie Ellman.

"I've heard they are very understaffed now and that's creating a lot of problems such as merging bus routes together," said Ellman.

Ellman said district officials told her that some transportation issues might be due to, "the Director of Transportation resigning."

When asked about the Omni bus issues, Palm Beach County Superintendent Dr. Art Johnson said he hasn't received the letters or heard about the complications. However,

"We're finding a new transportation director and I hope that will fix the problems."

However, a group of parents may still voice concerns at the March 21 School Board meeting, Ellman added.

Until then, parents say students will be late going to and coming back from school and they are even more concerned about safety.

"My son was let off at a totally different neighborhood. My question is: Who is responsible if "God forbid" one of our children doesn't make it home because there is no accountability on the part of our bus drivers?" wrote one parent.

Another parent letter stated, "The first issue is the lack of bus drivers. This causes the overcrowding of buses with three students to a seat and at times standing room only. Buses are carrying three busloads of kids on one bus. If there were to be an accident, it would be catastrophic."

But the late buses are not only affecting safety, according to Waronicki and other parents, student FCAT scores may also suffer.

"This bus got our kids to school late again and this time it was on the day of the FCAT reading test. By the time they got to school, my son had to run to class. I guess they go over the rules of the test before testing begins, but my son missed that. He got in his chair, put his backpack down and within minutes had to start taking the Reading FCAT. Again, this is totally unacceptable," Waronicki wrote. "My son usually does very well on these FCAT's. We do our part to prepare for this test, such as study, read, getting a good night's sleep, I make sure I cook him a good breakfast, but then what happens, Palm Beach County school transportation screws this up. This left him feeling hurried and rushed right before having to take the Reading FCAT. I sure hope this does not affect his FCAT score. Is anybody taking accountability for this bus tardiness?"

Planning & Zoning Board OKs changes to mall expansion plan

It's pretty common knowledge that Town Center at Boca Raton mall is getting larger.

The City Council last August approved plans for a 202,538 square foot expansion to be carried out in four phases.

Mall planners have been back to the drawing board to make some minor changes to the proposal adopted last year. The Planning & Zoning Board unanimously approved them all.

City Development Services Director Jorge Camejo also said the changes were minor.

According to plans filed in City Hall, the amended proposal lops one level off a proposed new parking garage on the south side of the mall. It will reduce parking by 332 spaces, but, overall, the plan still calls for 8,062 parking spots.

Developers also specified that the 22,804 square feet set aside for future use will be specifically for mall purposes.

The first phase of mall reconstruction was capped by the opening of the Grand Lux Café where TGI Friday used to be.

Executive Director Sam Hosn has told the *Boca Raton News* that the mall is incorporating European styling, which emphasizes the outdoors.

Among other changes coming to the mall, Hosn said, the existing Crate & Barrel store will move and enlarge into a two-story outlet. Its new location will be at the outer edge of the mall.

Macy's will add 82,000 square feet to its mall store and a new "lifestyle center" is in the works.



Although county district officials say the budget is tight, School Board members recently approved three new job classifications totaling \$336,490.

Those positions are General Manager— Enterprise Resource Planning, Transition Chief Technology Officer— Interim, and Restructuring Administrator.

Commissioners to hear request for storage building in West Boca

Palm Beach County Commissioners today will hear a request to construct a storage building in a development west of Boca Raton. The applicant, Jewish Community Facilities Corp., is seeking permission to reduce the size of one of its development "pods" to allow for a small storage building. "No additional changes are proposed, and access to the site will remain from 95th Avenue

Because it is part of the consent agenda, it may be approved without discussion.

South," says the agenda.

In January 2003, commissioners approved a plan for the 115.87-acre site to add two Jewish Association for Residential Care (JARC) units. About a year later, commissioners approved two "pods," called Rainberry A and B.

In the final site plan, Pod A was to include an 81,941 square foot/105-bed congregate living facility, 25,556 square feet of multi-

family residences and a 21,454 square foot resource center.

Pod B was designated for a 90, 000 square foot adult day care facility, 6,000-student elementary school, 60,000 square foot middle school and 70,000 square foot high school, as well as 80,000 square feet of shared space.

Under the proposal to be heard today, the square footage limitation for Pod A would be deleted to allow for a 672-square foot storage building. The proposal is also endorsed by county staff.

In another local item to be heard today, commissioners will correct an engineering condition for Balmoral at Delray Lake Estates. It will rectify an error inadvertently made in the original development order, officials said.

Hearings begin today at 9:30 a.m. in the Commission Chambers on the sixth floor of the County Governmental Center in West Palm Beach.

Growth hormones show no evidence of prolonging life

Surveyors of anti-aging elixirs tout human growth hormone as a remedy for all things sagging-from skin to libidos - and claim it can even prevent or reverse aging. But researchers at the Stanford University School of Medicine say there's no evidence to suggest that this purported fountain of youth has any more effect than a trickle of tap water when it comes to fending off Father Time.

"There is certainly no data out there to suggest that giving growth hormone to an otherwise healthy person will make him or her live longer," said Hau Liu, MD, a research fellow in the division of endocrinology and in the Center for Primary Care and Outcomes Research, and first author of a review study to be published in the Jan. 16 issue of Annals of Internal Medicine. "We did find, however, that there was substantial potential for adverse side effects."

Those negative side effects included joint swelling and pain, carpal tunnel syndrome and a trend toward increased new diagnoses of diabetes or pre-diabetes. "You're paying a lot of money for a therapy that may have minimal or no benefit and yet has a potential for some serious side effects," Liu said. "You've got to really think about what this drug is doing for you."

Growth hormone is widely promoted on the Internet and its use as a purported anti-aging drug has caught the attention of the popular media, ranging from the "Today Show" to Business Week.

Between 20,000 and 30,000 people in the United States used growth hormone as an anti-aging therapy in 2004, a tenfold increase since the mid-1990s, according to the authors of an unrelated study published in the Journal of the American Medical Association in 2005. This increase comes despite both the high cost of such therapy - often more than \$1,000 a month - and the illegality of distributing growth hormone for anti-aging therapy in this country. Those numbers prompted Liu and some colleagues to see if the medical literature provided any support for such therapy.

Licensing may be answer to global marketing

have been working with a client that believes he possesses one of the most robust and technological breakthroughs that the world has seen in the last 50 years. The group is comprised of two technologists and a business development and operations partner.

During the last six years, the business partners have been working together researching and developing the technology to the point where they can now create specific applications from the technology.

In this case, the technology has the potential to be used in many applications benefiting the industrial, military and aviation industries.

Decision time

Once an application or two has been perfected, then the principals have a major decision to make. Do they move forward and develop what could end up being a billion dollar business? Or do they turn it over to another company who has the money, background, contacts and skill set to fully exploit the technology to its full potential?

The concept of licensing can give an inventor, developer or creator of a product or technology the option of turning a well designed, well conceived and perfected product into a well commercialized and well promoted product. Quite often, inventors of technologies and products are idea driven and not necessarily business savvy. You might even say that they possess the ability to develop and create many things but don't have the keen sense or the desire to take it to the marketplace.

A major benefit

That is where licensing can be a tremendous benefit for an inventor or developer. A good licensing agreement can be a win/win for both the inventor and the licensee, the promoter, manufacturer or marketer.

Technology licensing is a contractual arrangement in which the licensor's patents, trademarks,

service marks, copyrights, trade secrets, or other intellectual property may be sold or made available to a licensee for compensation that is negotiated in advance between the parties.

This compensation, commonly referred to as royalties, may be a lump sum royalty, a running royalty, which is a royalty that is commonly based on a specific volume of sales or production, or a combination of both. Inventors and developers frequently license their technology to companies that conduct business in the industry that the technology is based in order to manufacture, market and/or fully exploit the technology into the marketplace.

A technology licensing agreement usually enables a firm to enter a specific market quickly, and poses fewer financial and legal risks. The inventor or developer is not bothered with owning and operating a manufacturing facility, developing and executing major sales and marketing plans or employing and managing a business operation to further support the overall growth of the products that support the technology.

Licensing also permits the inventor or developer to leave behind all of the problems of running a business and just focus on the existing technology and its future enhancements. For these reasons, licensing can be a particularly attractive method of "exporting" for inventors or developers with little business experience or who simply possess the drive to create and not market and sell.

Helps service trade

Technology licensing is not limited to the manufacturing sector. Franchising is also an important form of technology licensing used by many service industries. In franchising, the franchiser, called the licensor, permits the franchisee, called the licensee, to employ its trademark or service mark in a contractually specified manner, in the form of a franchise agreement, for the sales and marketing of goods or services.

The franchiser usually continues to support the operation of the franchisee's business by providing advertising, accounting, training, and related services and in many instances also supplies products needed by the franchisee.

Technology licensing has certain potential drawbacks. One negative aspect of licensing is that control over the technology is weakened because it has been transferred to an unaffiliated firm. If that firm does not have the ability to promote the technology properly then the inventor or developer might not get the most bang for the buck.

Make sure when negotiating a licensing agreement to include specific commitments by the licensee as to how, what, when and where they will be promoting the technology.

Most importantly, make sure that if the licensee does not perform or meet the requirements to promote, market and sell the technology or products then you, the inventor or developer, can regain full control of the technology in order to market it yourself or find another partner to market and sell for you.

Delray rejects historic guidelines; loses appeal to move bungalow

Residents acknowledge that Delray Beach has a vivid history.

But trying to keep historical districts intact is a different story.

The Delray City Commission on Tuesday not only rejected a new set of guidelines for making changes to homes in historic districts, it also lost a battle to move a historic home onto the Community Redevelopment Agency's campus.

A shorthanded commission voted, 2-1, in favor of overriding the Historical Preservation Board's decision to deny permission to move a house on Swinton Avenue to the rear of the CRA building. City Attorney Susan Ruby said three votes were needed to pass the appeal, so the HPB's ruling stands.

Commissioner Rita Ellis was not present at the meeting and Mayor Jeff Perlman had to recuse himself because his wife, Diane Colonna, is the CRA's executive director.

The commission, an attorney for the owner of the home and several speakers hashed over the matter for about an hour before the vote was taken.

Colonna said the Swinton Avenue home and a house that is now used by the CRA as its headquarters were both brought to Delray Beach from West Palm Beach. The bungalow on Swinton was sold to a private owner.

"He needs more space," she said.
"He would build a new building" if
the bungalow were transported to the
CRA campus. "We were surprised at
the reaction [of the HPB]," she said,
who felt it would degrade the historic

district.

The CRA did not appeal the HPB's ruling, City Commissioner Brenda Montague did. She and Commissioner Jon Levinson voted in favor of the appeal. Commissioner Fred Fetzer voted no.

A number of people spoke at a public hearing, many backing the HPB's ruling.

Attorney Michael Wiener, speaking for the homeowner, said it is "inconsistent with the statutes" to leave the house where it is. "It would be better protected on the CRA parcel."

But foes of the move said the house, as it currently stands, is part of the Swinton streetscape. At the CRA, they said, it would be placed in an alley facing a Dumpster.

More improvements needed at Home Depot

Dear Mr. Berko:

What do you think of Citigroup, which yields 3.9 percent? I am thinking of buying 50 shares because its dividend growth has been excellent while its stock performance has been poor. And I think the stock could now begin to move. Your opinion would be appreciated. I'm also looking at Home Depot that hasn't moved much in the past 4 years either. Now that Mr. Nardelli (whom you said should lose his job) is gone, the stock could also move up. Home Depot's revenues and earnings have been quite good and maybe the stock will reflect that too. So what do you think about this one also?

Dear W.T.:

I met Robert "Bobby" Nardelli a few years ago and I was totally underwhelmed. He believes in his infallibility, that his pronouncements are inerrant. It really takes a unique man to possess that astonishing degree of confidence. Well Nardelli believed he was anointed as chief executive officer of HD rather than appointed. Under his reign, Home Depot Inc. (HD-\$38.39) revenues grew by 35 percent, net income increased 80 percent, senior management suffered recurring laundry problems, tens of thousand of store employees stopped caring about customers and while the Dow rose to record levels, HD shares were flat as window glass. But few people noticed that despite rising revenues, profits and margins, HD's lifeblood, free cash flow, just flat

After Nardelli was passed over to become chief executive officer of General Electric and hired by HD, he refused to have his \$39 million annual salary tied to the performance of HD's stock. That was an impressive negotiation move and HD's inutile board of with 3.2 million customers and 3

"stinker." And even though the new CEO Frank Blake (whose salary is \$1.5 million) is one of the sharpest tools in the shed, I'm still not comfortable with the stock. I know that A.G. Edwards, J.P. Morgan, Standard & Poor's and Lehman Brother have a "buy" rating on Home Depot and I know that Nardelli no longer terrorizes the rank and file. However, I think Frank Blake's' new broom does not sweep clean enough.

Nardelli's henchmen, who replaced some 20-plus senior Home Depot executives, still forage the corridors at HD's Atlanta headquarters. Sadly, these Nardelli clones continue to intimidate the loyal HD people, so those guys gotta go. And while it's convenient to blame Nardelli for HD's poor stock performance the buck really stops at HD's feckless board of directors who allowed themselves to be bullyragged by Nardelli. Bobby sat on this throne for years and HD's limpsy, anile board basically rubber-stamped his decrees. So the board's gotta

Nardelli's departure has removed the main source of poison but the remaining clones and the abiding board of directors still foul the company's water. When Frank Blake's broom really sweeps clean I may feel comfortable recommending the stock. Until then, I think the stock will remain in its narrow range.

Citigroup (C-\$51.44) is a dandy company with a Jim-dandy management problem. Revenues have grown 60 percent in the past five years, dividends have tripled but according to Standard & Poor's, C's earnings seem to change direction like Mexican jumping beans.

Citibank includes Smith Barney, Travelers Property & Casualty, Primerica Financial Services, Banamex and Egg Banking, the world's largest pure online bank directors fell for it hook, line and million credit card customers in

England. Ever since Sandy Weil retired, C has suffered from a management vacuum. But CEO Charles Prince, who is a swell, knowledgeable and experienced lad, lacks Sandy Weil's peoplepicking and communication

It seems that Prince enjoys playing musical chairs in the executive suite, which doesn't play well on Wall Street. Prince's decision to invest more assets overseas (C's purchase of Central America's largest credit card issuer, its huge stake in Turkey's largest bank, plus its interest in an Asian insurance company, to name a few examples) has caused some disaffection among investors. Sandy Weil may not have chosen wisely.

There are many on the Street who believe C's management consists primarily of B players who are not up to the job of running an A-class bank. And this is the genesis of C's poor stock performance since 2002, when it traded at \$52 a share. Earnings for 2007 are unimpressive and so is the stock's performance. The stock could move up a few points but not enough to make it an attractive purchase. Stay away.

Tucker, a West Boca High senior, recently won first place and the gold medal at The Art Institute of Fort Lauderdale's Best Teen Chef 2007 Local Culinary Com-

"It felt good. A lot of hard work paid off," said the 18-year-old. "When I compete I like to have a good time as well and put on a little show."

The competition consisted of creating a shrimp cocktail appetizer and a sautéed chicken dish in 90 minutes. Four judges critiqued the participants on "taste, presentation, creativity, originality and kitchen sanitation," according to Tucker.

"It was just how you interpret and put your own twist on the dish," he said. "Basically I followed the rules and experimented with flavors for the sauce."

Judges said Tucker's talent won over the competition. Other participants included: second place winner and silver medalist Maria Lowenthal; third place winner and bronze medalist Travis Boles; Sarina Riley; and Jodi-Lee Mor-

"We had an exceptional group of competitors who prepared a menu of shrimp cocktail, sautéed breast of chicken, fresh broccoli, and rice pilaf," said Art Institute of Fort Lauderdale Chef Director Jack Kane. "They all did extremely well but we can only send one to Dallas."

Tucker's next stop is Dallas, Texas, where he will compete with 22 other high school seniors May 5 for a chance of taking the Best Teen Chef title and a full-tuition scholarship worth approximately \$40,000.

"Hopefully, I'll go to nationals and take first place and then I can really call myself the best teen chef," Tucker said.

Nursing mothers need calcium

Mothers who breastfeed should be sure to have enough calcium, or may risk bone loss around teeth and gums, according to a new study in the Journal of Periodontology (JOP).

Researchers from Tohoku University in Japan investigated if lactation affects alveolar bone loss, the bone surrounding the roots of teeth, in rat models of experimental peri-

are lactating could put the bone structures around their teeth at risk, especially when there was not enough calcium in their diet.

"Our research emphasized the importance of having a high-calcium diet while breast-feeding," said Dr. Kanako Shoji, Division of Periodontology and Endodontology at Tohoku University. "While our study was on a rat population, the

odontitis. They found mothers who evidence confirmed that breastfeeding can cause increased bone loss in the mother, especially when the mother has insufficient calcium intake. But additional studies in human populations are necessary to confirm these findings."

The study showed that all groups with insufficient calcium intake saw an acute inflammatory reaction in periodontal tissues and disruption of the gingival epithelium, the tissues surrounding the teeth, in addition to increased attachment loss, and increased alveolar bone loss. Those groups which were lactating saw even greater attachment loss and bone loss.

"We know a high-calcium diet can promote healthy teeth and gums," said Dr. Preston D. Miller, DDS, President of the American Academy of Periodontology, "But this research indicates that nursing mothers should be especially conscious of having enough calcium

in their diet. While breast milk is critical to their baby's bone development, mothers should be sure to have enough calcium, or risk bone loss in her mouth, which can worsen periodontal diseases. Given that a thorough periodontal evaluation should be done as soon as a woman finds out that she is pregnant, monitoring periodontal tissues, including more frequent cleanings during pregnancy and continuing until 3 months after delivery, will help assure periodontal health."





Bulls win extra-inning thriller

It was the game that would never end.

Four hours and 13 innings of baseball, a seventh-inning rally, and two defensive gems from each team that saved the potential winning runs from crossing the plate.

West Boca Raton High and Wellington High played a classic on Tuesday night and into Wednesday morning, and when Bulls reliever Matt Cornwell grabbed a comebacker from Nick Ferrasi, went home and then catcher Rick Versace threw to first for the gameending double play, the Bulls had finally prevailed, 4-2.

"No one deserved to lose this game," West Boca Raton coach Brian Joros said. "Wellington played great, I can't say enough about their pitchers and the defensive plays they made to keep us from scoring."

The game's biggest hit came from its smallest player, Bulls junior second baseman Rick Conaway. Conaway came into the game in a pressure situation: the bases were loaded and there was one out. The Bulls had been in the same situation in the ninth inning, and Wellington turned a 4-2-3 double play to get out of the jam.

This time, Conaway lashed a Trey Ferrano pitch to the hole between first and second. The ball took a bad hop though, and bounced over the second baseman's head for a two-run single that provided the winning margin.

"He's done that two or three times this year, where he's come in when a starter hasn't performed

and he's come through pretty pitched a no-hitter and struck out 12 much every single time," Joros

Conaway said he was thinking, "Put the ball in play, and things will happen."

It could have been cause for West Boca players and coaches to relax, but true to the nature of this game, it wasn't over yet.

After Cornwell retired the first hitter, David Cheatham, Evan Stermer and Bryan Adametz followed with three consecutive singles to load the bases.

That set the stage for Cornwell's game-ending heroics.

"One of the reasons we put him in to pitch is he fields his position so well," Joros said of tabbing his starting shortstop for relief duty. "You saw he fielded the ball, throws it home, then gives us a chance for the double play. That was part of the reason behind the move."

For awhile it looked like the Bulls (13-1) were on their way to another easy win, as starter Brian Busch struck out 10 batters and had a shutout going through the sixth.

But Wellington scratched for two runs, including an RBI sacrifice fly by Cheatham that scored Sean Murrell with one out in the seventh to tie the game.

Then came the extra inning odyssey, in which each team put at least two runners on for each of the next three innings, but neither team would score until Conaway came through in the 13th.

The Bulls' reward was another late game against Battle Ground Academy (TN), which defeated Cardinal Newman High 2-0 in the early game Tuesday. Starter Navey Moore in 6 1/3 innings for the Wildcats.

Meanwhile, the Wolverines' game against the Crusaders in the consolation bracket was pushed back from 10 a.m. to 1 p.m. Wednesday.

Breaking down the Sweet 16

Last week several brackets were busted (including mine), as the first weekend of the 2007 NCAA Men's Basketball Tournament provided few upsets and fewer memorable games.

Announcers everywhere were lamenting the fact that the first two rounds were the least exciting in some time, and they were right. Other than three overtime games on Saturday (including Ohio State's memorable rally against Xavier), last weekend was underwhelming.

But the good that came form those opening rounds is that just one of the eight 1 and 2 seeds (Wisconsin) has been eliminated, meaning that the best basketball should be yet to come, starting with Thursday's Sweet 16 and ending in the Elite Eight Sunday.

So, here's a breakdown of the action this weekend:

EAST

North Carolina vs. USC: One of the shakier No. 1 seeds has had its moments of uninspired play so far, as the Tar Heels toyed with Eastern Kentucky, only to watch as a 31-4 run cut the Carolina lead to four. The Tar Heels, of course, pulled away, but they still appear capable of a tournament washout

USC is the surprise team, eliminating fan favorite Texas and Freshman of the Year Kevin Durant with a swarming defense. Now, the impressive Trojans take on another team that likes to run all day in the Tar Heels.

North Carolina is more than just a one-man show however, and the Heels

should advance to face Georgetown, which will take out Vanderbilt in its Sweet 16 showdown.

The Hoyas are playing like it's 1985 again, slowing down the tempo and using a fine big man (Roy Hibbert) and Big East Player of the Year Jeff Green to pace the attack.

Georgetown should prove much to physical for the Heels, and they will slow the game down enough to knock Carolina out in the Elite Eight.

WEST

UCIA and Pittsburgh clash in a meeting of teams with similar styles. Ben Howland left the same rugged imprint on the Panthers as he has with his current team, and both teams will make this a physical game.

But the Bruins have more options offensively, and Player of the Year candidate Aaron Afflalo is a clutch scorer, nailing four free throws in the last 90 seconds to knock off Viginia in the second round.

The Bruins should face Kansas, which has too much talent for Southern Illinois.

The Jayhawks boast several players who can take over a game, from Mario Chalmers to regular season leading scorer Brandon Rush, to freshman sensation Julian Wright.

Kansas has also rolled through the tournament so far, handling Kentucky easily last week in an impressive victory. Kansas is the pick to move on.

MIDWEST

The Florida Gators may have played unevenly in wins over Jackson State

and Purdue, but the national champs are still the team to beat. Butler won't have a chance against Florida's superior depth and talent, and that should lead to an entertaining showdown with Oregon, which has the defense to derail UNLV.

If Aaron Brooks and the Ducks' three-point shooters get hot, Florida could be in trouble. But Oregon, despite the fine defense the team has displayed since the PAC-10 tournament, will have no answer for the Gator's power game of Joakim Noah and Al Horford. Florida will advance to the Final Four for the second straight year.

SOUTH

Ohio State has been even shakier than the Tar Heels, as the Buckeyes needed a miraculous rally just to top Xavier in overtime in the second round.

Tennessee used the same formula the Musketeers used in almost beating the Vols earlier this season: lure center Greg Oden away from the basket and get him into foul trouble.

Tennessee has a clutch scorer in Chris Lofton, but the Vols don't play good enough defense or have enough scoring options to take out the Buckeyes.

That will lead to a battle with Texas A&M, which should get past overrated Memphis in the Sweet 16.

The Aggies have one of the best clutch shooters left in Acie Law IV, and their rugged defense should cause Oden and the Buckeyes problems.


This will be a close game, but Texas A&M will pull off the upset and make its first Final Four trip in school history
