Board looks to catch boundary jumpers

Picture this: It's approaching the last year of high school and once again time to provide proof of home address. But your family has moved outside of the school's boundary that has been your home away from home for three years.

What to do?

Many students and families are giving false addresses.

Although those students may not realize that one "little white lie" causes a ripple effect of: overcrowded classes, longer lunch lines, and a later dismissal.

And the problem is more and more students and families are giving false addresses to remain at choice schools. Thus, overcrowding Palm Beach County schools.

But not for long. The Palm Beach County School Board is cracking down on boundary jumpers.

Meaning it won't be easy for students to attend school with a false address.

The board recently approved a proposed new policy to strengthen requirements to catch boundary jumpers or hoppers, or those students using false addresses to attend county schools outside boundaries. The policy must receive final adoption in July.

Under the new policy, upon enrollment students must show two proofs of address. Students can show: a current telephone or electric bill, rent receipt with name of tenant and landlord and contact information, lease agreement with name of tenant and landlord and contact information, mortgage commitment, automobile insurance, current Florida driver's license, cellular telephone bill, credit card statement, U.S. postal service confirmation of address change request or evidence of

Boca fire lieutenant receives service award in education

Agilysys continues to buy; acquires InfoGenesis for \$42 million

> InfoGenesis is involved in casinos, hotels and resorts, cruise lines, stadiums and foodservice. The acquisition will provide Agilysys a complementary offering that will extend its reach into new segments of the hospitality market, broaden its customer base and increase its software application offerings, according to Agilysys CFO Martin Ellis.

- While in the near term return on invested capital will be diluted due to acquisitions and legacy costs, the company continues to target long-term return on capital of 15 percent.

Adding to its growing portfolio of acquisitions, Boca Raton based Agilysys has agreed to spend \$42 million for InfoGenesis, a southern California based privately held IT firm focused on hospitality software solutions.

Only last week Agilysys announced its \$100 million acquisition of Edison, NJ based Innovativ Systems Design, Inc., a privately held firm that, and at approximately \$260 million in revenues, is the largest U.S. commercial reseller of Sun Microsystems servers and storage products.

The Innovativ acquisition "will establish a new and significant relationship between Sun and Agilysys," said Agilysys President and CEO Arthur Rhein. "Moreover, the addition of Sun expands Agilysys' offerings to include four of the most pervasive computer technology suppliers: EMC, HP, IBM and Sun," he said.

Hospitality Industry

InfoGenesis is involved in casinos, hotels and resorts, cruise lines, stadiums and foodservice. The acquisition will provide Agilysys a complementary offering that will extend its reach into new segments of the hospitality market, broaden its customer base and increase its software application offerings, according to Agilysys CFO Martin Ellis.

"With some of the world's leading properties as customers, the acquisition of InfoGenesis will further strengthen Agilysys' market position in the hospitality industry," said CEO Arthur Rhein. "The acquisition will also provide us a competitive advantage with enhanced levels of integration between property management, POS, and inventory and procurement systems, as well as our golf course and spa management applications.

Rhein added "over the years, we have worked closely with InfoGenesis at a number of mutual customer locations and together will market a powerful single-source solution that enables properties to increase guest loyalty and overall

profitability."

In addition to its California headquarters, InfoGenesis has a customer operations and support center in Las Vegas. The company has approximately 170 employees.

Rhein added that the InfoGenesis announcement continues the company's recent aggressive acquisition activity. Over the last six months, this is the second acquisition Agilysys has made in the hospitality IT market and the fourth overall. In addition to the Innovativ acquisition, recent buys include:

Stack Computer, a technology integrator with a focus in high availability storage infrastructure solutions.

Visual One Systems, a developer and marketer of Microsoft(R) Windows(R)-based software for the hospitality industry including applications in property management, condominium, golf course, spa, point-of-sale, and sales and catering management.

Rhein said, "I continue to be impressed with our organization's ability to execute our strategic plan, including the rapid identification, negotiation and integration of targeted acquisitions."

Long-Term

Based on its growth plans, CFO Ellis said the company has established several long-term financial goals, including:

- Grow sales from approximately \$500 million to \$1 billion within two years and to \$1.5 billion in three years.
- Target gross margins in excess of 20 percent and EBITDA margins of six percent within three years.
- While in the near term return on invested capital will be diluted due to acquisitions and legacy costs, the company continues to target long-term return on capital of 15 percent.

The recent acquisitions are consistent with these plans, according to Rhein. Including the acquisitions listed above, Agilysys has pro forma revenues in excess of \$850 million, according to Ellis.

Boca student traveling to D.C. for an educational journey

Carlos LaRocca will soon leave Boca Raton for a weeklong educational journey to the heart of politics in the nation's capital.

For the first time, LaRocca will visit historic sites, meet with government officials and view policymaking in Washington D.C.

LaRocca, a junior at Spanish River High School in Boca Raton, will attend Presidential Classroom's National Security in a Democracy program in Washington D.C. from June 10 to June 16.

"I'm excited," said the 15-year-old, who was chosen because of academic achievement. "I'm looking forward to meeting new people and learning more about national security."

Presidential Classroom's mission is to provide civic education programs for outstanding high school students using Washington D.C. as a classroom. More than 120,000 students from across the United States and around the world have attended Presidential Classroom's weeklong programs, gaining knowledge, insight and experience from this educational opportunity, according to its website.

Through the program, students experience the inner workings of government and policy formation firsthand, through seminars and site visits in Washington D.C. During the weeklong program, PC scholars interact with Washington insiders including members of Congress, presidential appointees, senior military officials, top business leaders and journalists.

Students also observe the U.S. Congress in action and visit congressional offices and debate current issues with peers from the United States and abroad. Additionally, students visit sites such as the U.S. Department of State and Arlington National Cemetery. Additional program highlights include a seminar on the floor of the U.S. House of Representatives,

a tour of the Pentagon and visits to the Federal Bureau of Investigation Training Academy and Manassas National Battlefield in Virginia.

"Presidential Classroom is dedicated to challenging the leaders of tomorrow to learn, understand and take action on the formidable problems that face our nation and our world," said Presidential Classroom Executive Director Elizabeth A. Sherman, Ph.D.

Sherman added, "With Washington D.C. as our classroom, we attract outstanding high school students to a series of discussions with influential leaders and policy makers, site visits to national institutions, exercises and debates on topics of prominent importance, and interaction with teachers, mentors and peers. I am delighted to welcome this student to join Presidential Classroom for what promises to be a vital step toward civic engagement and meaningful participation in public leadership."

Presidential Classroom focuses on communications and journalism, science, technology and public policy, law and justice, global business and entrepreneurship, and the National Security policy. Students can earn college credit

Townhouse plan for Boca Teeca re-ignites anger

When a developer wanted to come in and reconfigure the golf course at Boca Teeca, allowing him to build a couple of hundred townhouses on the property, a lot of people opposed it. But a lot of them went along with the plan.

So many, in fact, that when it was put to a vote, a majority of residents voted to allow the lifting of a permanent recreational zoning designation on that piece of property.

That developer will present his proposal to the Planning & Zoning Board at its meeting tonight at 6:30 in City Hall. It appears—from emails received in City Hall and at the *Boca Raton News*—that a lot of people—most of them against the plan—will show up at the session.

Dennis Taback, whose company, MCZ Centrum Florida V, bought the golf course for \$7.2 million in December 2004, wants to construct 211 town homes on about 30 acres on the west side of the golf course. Also in the mix is a new 10,000 square foot social center on the southwest side of what will remain a 27-hole golf course surrounding the development along NW Second Avenue.

Little change

MCZ has reduced the number of units from 225 to 211, but the rest of the plan remains virtually the same.

The Federation of Boca Raton Homeowner Associations got a momentary vision of tonight's session. At its meeting Tuesday,



Charles Gershon of Teeca Woods said 33 homes will be "severely impacted" by the construction. He accused the developer of "promising" a new social hall and "putting money into condo treasuries" to get his way.

He also asked the federation to support the golf course opponents.

Shirley Schnuer, president of the Boca Teeca Unit Owners Association, rose and shouted that what Gershon said "wasn't true." She asked that the motion be tabled until the proponents have their say.

Before President Linda Bauman halted discussion, several other people rose and started to yell and point fingers.

"Benefits" community

A spokeswoman for the developer said "plans call for 211 town homes coupled with benefits for the community, including a multi-million dollar update to the country club, expansion of the inn and a new 10,000 square foot social center. The plans are intended

to revitalize a community that hasn't had any major upgrade in more than 25 years."

She noted that Boca Teeca's 1,600 unit owners "consented by a large majority to lift the deed restriction. That allows for the new development by reconfiguring a small portion of the community's south course, while retaining 27 holes of golf and golf course views for existing homeowners."

"A catalyst for the plan is the expiration of mandatory club membership for Boca Teeca's existing unit owners at the end of 2009," she said. "This plan builds long-term economic viability of the club, with upgraded facilities and income from the new town home buyers' memberships."

But in an email to the City Council, Katherine Cabra of Fairway Drive said: "Please listen to the residents of the area. We are against any more development in the area. How can you in good conscience approve building, when we are not sure there is enough wa-

Delray Commission commends Ocean Rescue team for saving seven people

Five inexperienced swimmers were nearly swept out to sea May 19 by a rip current that slammed the Delray town beach.

Two others jumped in to help — and they were also caught in the grasp of the tugging current.

Five members of the Delray Beach Ocean Rescue team quickly jumped in and managed to bring all seven to shore without injury. For that, the team members — Ed Noon, Mike Gaylord, Conor Gorman, Luigi Pratt and Scott Moore — have won the praises of the Delray Beach City Commission.

Noon and Pratt joined Superintendent Bob Taylor to accept

commendations from the City Commission at its meeting Monday. Mayor Rita Ellis said the men “used their skills” to “avoid a potential tragedy.”

Taylor noted that this past May, the ocean has been very turbulent, and many have drowned as a result of rip currents. He said May is normally a quiet month.

Other business

In other business, the commission gave initial approval to a land development regulations amendment to provide an exemption to the prohibition of office uses on the ground floor of buildings on East Atlantic avenue. The matter proceeds to a public hearing at the next meeting June 19.

Currently, first floor offices along East Atlantic Avenue are considered non-conforming uses.

Also, commissioners approved the request of the Zion Study Circle to use the city seal in its early history book about Delray Beach.

Also approved was a request to conduct Art & Jazz on the Avenue June 28 from 6 to 10 p.m. The temporary permit will allow the closing of several downtown streets. The approval also authorizes staff support for security and traffic control, banner hanging and removal, barricade set up and removal and cleanup.

Human Resources and You

A recent federal appeals court decision highlights a potentially treacherous problem: the possibility that an employee handbook creates terms that violates the National Labor Relations Act (NLRA). The decision, focusing on a seemingly non-controversial policy concerning the confidentiality of employer records in a non-unionized setting, is of serious concern to both non-unionized and unionized employees alike.

The policy at issue in *Cintas Corp. v NLRB*, 2007 U.S. App. Lexis 6075 (D.C. Cir. Mar. 16, 2007), was found in a section of Cintas’s handbook, titled “Cintas Culture,” which describes its “principles and values.” It included the following discussion of how employees (referred to by Cintas as “partners”) are expected to treat confidential information:

“We honor confidentiality. We recognize and protect the confidentiality of any information concerning the company and its business plans, partners, new business efforts, customers, and accounting and financial matters.”

The handbook further stated, in another section, titled “Discipline Policy,” that employees could be sanctioned for “violating a confidence or [for the] unauthorized release of confidential information.”

The United States Court of Appeals for the District of Columbia Circuit affirmed a decision of the National Labor Relations Board (NLRB), which held that the policy violated Section 8 of the NLRA. Section 8 prohibits employers from “interfere[ing] with,

restrain[ing], or coerce[ing] employees,” 29 U.S.C. § 158(a)(1), in the exercise of their Section 7 rights “to self-organization, to form, join or assist labor organizations . . . and to engage in other concerted activities for . . . mutual aid or protection.” 29 U.S.C. § 157.

The court agreed with the NLRB, even though the confidentiality provision did not specifically restrict Section 7 activity (e.g., by instructing employees not to discuss wages or other terms and conditions of employment with each other). Disturbingly, the court held that the provision violated the NLRA because “employees would reasonably construe the language to prohibit Section 7 activity.”

The court, and the board, based this finding on the breadth of the confidentiality provision — specifically the “all-encompassing phrase ‘any information concerning . . . its partners’” — which made no effort to distinguish Section 7 activity from violations of company policy. Moreover, the court agreed with the NLRB that whether anyone had actually been disciplined under the policy for sharing wage information was irrelevant, because the “mere maintenance of a rule likely to chill Section 7 activity, whether explicitly or through reasonable interpretation, can amount to an unfair labor practice.”

Retiree named ‘Ombudsman of Year’ for Palm Beach County

Delores McCarthy never imagined she would be celebrating her 10th year of retirement as “Ombudsman of the Year” for the Palm Beach Council of Florida’s Long-Term Care Ombudsman Program.

Shortly after retiring from a long nursing career, McCarthy began searching for a way to give back to her community. She found her way with the ombudsman program, which seeks to ensure the health, safety, welfare and rights of frail elders living in local nursing homes, assisted living facilities and adult family care homes.

She received the “Ombudsman of the Year” honor earlier this month for her outstanding commitment to advocating for the long-term care facility residents of Palm Beach County. When she became an ombudsman, she agreed to volunteer 20 hours a month, but she often puts much more time into her work with those she

helps.

“It’s hard to explain the satisfaction I get out of it, getting to know people and hearing their stories,” said McCarthy, a mother of three and grandmother of four who said she’s honored to receive the award. “I most enjoy finding solutions, because whatever a person’s problem is, it is real to them.”

According to the LTCOP annual report — available at <http://elder-affairs.state.fl.us> — 32 volunteer ombudsmen from the Palm Beach Council investigated 736 complaints last year. Statewide, volunteer ombudsmen aided 50,000 of Florida’s 163,000 long-term care residents with issues ranging from poor menu quality and billing practices to medication administration and improper evictions.

“Our volunteer ombudsmen are extremely dedicated,” said State Long-Term Care Ombudsman and Program Director Brian Lee. “It is important to recognize the standard they are setting. I

hope this recognition encourages more people to get involved in their community by becoming ombudsmen.”

Administered by the Florida Department of Elder Affairs, the Long-Term Care Ombudsman Program trains and certifies its more than 300 volunteers to personally respond to the concerns of elders residing in nursing homes, assisted living facilities and adult family care homes, as well as those of their families and other concerned citizens. All program services are provided at no charge, and all complaints are confidential.

Klein joins in introducing bill to replace deteriorating hurricane tracking satellite

Concerned that the most accurate hurricane tracking satellite is in danger of falling into disrepair, U.S. Rep. Ron Klein joined Rep. Charlie Melancon (D-LA) today in introducing the "Improved Hurricane Tracking and Forecasting Act of 2007." This bill would authorize the necessary NASA funding to design and launch a replacement satellite for QuikSCAT. Sen. Mary Landrieu (D-LA), Bill Nelson (D-FL), Mel Martinez (R-FL), and John Kerry (D-MA) introduced a companion bill in the Senate.

"More than any other tracking tool, the QuikSCAT satellite provides the most accurate data for forecasting hurricanes," said Klein. "Given that the satellite is in danger of going off-line, it is critically important Congress appropriate the necessary funding to get replacement technology in place."

"That is why I am joining my friend from Louisiana, Rep. Charlie Melancon, to introduce the Improved Hurricane Tracking and Forecasting Act of 2007. This bill would provide the funding necessary to design and launch a re-

placement satellite for QuikSCAT. Taxpayers in Florida and throughout the country expect the National Hurricane Center to provide them with life saving information, and Congress has a responsibility to provide the Hurricane Center the resources it needs to generate this data."

In 1999

NASA launched the QuikSCAT satellite in 1999. After its launch, The QuikSCAT satellite proved to provide valuable data that helps to more accurately track and forecast hurricanes and other deadly storms. Originally designed for a life expectancy of three years, QuikSCAT has now been operating for eight years with no replacement set to launch in the near future.

The "Improved Hurricane Tracking and Forecasting Act of 2007" would fix this problem. It would authorize \$375 million for NASA to design and launch a replacement satellite for QuikSCAT, incorporating improved technology to continue forecasting for hurricanes, coastal winds and storm surge, and other weather-related disasters. The bill would also re-

quire that NASA provide annual reports on the status of the program to ensure fiscal responsibility and up-to-date operational information on the status of the satellite.

"Allowing our ability to track hurricanes to deteriorate before our very eyes is unacceptable," said Klein. "Given that over half of all Americans live within 50 miles of the coast line, this is not just an issue that affects us in South Florida, but is an issue that impacts a majority of the American people. I am committed to working with both Democrats and Republicans in Congress to ensuring that we secure the funding we need for this vital satellite."

Since learning about the pending demise of the QuikSCAT satellite, Rep. Klein has made it a top priority to find a replacement. He has met with representatives from the National Weather Service, the National Hurricane Center, and the Air Force Reserve to discuss alternatives to QuikSCAT, and is now pleased to join Rep. Melancon in introducing the "Improved Hurricane Tracking and Forecasting Act of 2007."

1 in 3 HIV positive gay men report unprotected sex

A tale of 3 cities -- Persisting high HIV prevalence, risk behavior and undiagnosed infection in community samples of men who have sex with men.

More than one in three HIV positive gay men say they have unprotected sex, reveals a community survey, published ahead of print in the journal Sexually Transmitted Infections.

And almost one in five HIV negative men said that they do the same, the figures show.

The findings are based on a survey of men at gay bars, clubs, and saunas in London, Manchester, and Brighton between 2003 and 2004.

The surveys, which were car-

ried out at 90 venues, involved information on lifestyle, background, and sexual behavior.

Almost 3600 questionnaires were handed out, 2640 of which were completed. Saliva samples were also requested to find out about HIV prevalence, and 2311 men agreed to provide these.

The rate of HIV infection was highest in Brighton, at almost 14 percent, and lowest in Manchester, at 8.6 percent.

But the rates of undiagnosed infection was high in all three cities, ranging from one in three in Brighton to more than four out of 10 (4 percent) in London.

Across the entire sample, one in three men who was HIV posi-

tive did not know they had the infection.

This was despite the fact that over two thirds of these men said they had been to a sexual health (GUM) clinic within the past year.

Almost one in five (18 percent) of HIV negative men and over a third (37 percent) of HIV positive men said they had had unprotected sex with more than one partner in the past year.

Over the same time period, one in five HIV negative men and four out of 10 HIV positive men said that they had had a sexually transmitted infection.

correspondence, or declaration of domicile form from county records department.

"I think it will help control our headaches," said School Board member Bob Kanjian, referring to boundary jumpers.

The School Board received a migraine earlier in the year when 45 students reported that they used a friend's address or old address to stay at Jupiter High School. Twenty-two were seniors.

In another incident, the district school food service department sent out letters for free and reduced lunch meals, 7,000 of those letters were returned undeliverable. Thus, the district formed

the address verification committee to catch boundary jumpers and families.

More Proof

Additionally under the proposed policy, parents of all new and returning students must annually complete a new and returning student registration

form. Also, additional proof may be required if a county school exceeds 100 percent enrollment capacity. As for capacity, Kanjian thinks the bar should be set before schools are overcrowded.

"It should be at zero percent capacity not 100 percent," he said.

Besides at or over capacity, district officials say they look at

"I think the principal's role is improper. We need to take principals out of politics," Kanjian said.

However, district officials say principals were chosen because "they know the students personally."

Penalty

If caught knowingly providing a false address in writing, the penalty could be a misdemeanor of the second degree. Those students will also be removed from that school and reassigned to the school that is in the boundary, although parents will have ten days from the notification to

file an appeal.

Some board members suggested creating a milder penalty for those who "come forward."

"We should not yank them out in the middle of the year," said board member Debra Robinson.

It may be time to think about raising some capital

Some of the most common ways to attain capital for your business are by credit cards, friends and family, home equity loans, personal notes or loans from a bank, borrowing or cashing in pensions, IRA's, 401(k)'s and other types of retirement accounts, private investors, personal savings, federal state and local governments, venture capitalists, private equity funds and your vendors and suppliers. Each and every one of these alternatives can ultimately put capital into your coffers or provide you the credit that you need for your business. They will also dictate the terms and conditions of your use of that money in your business.

Acceptable terms

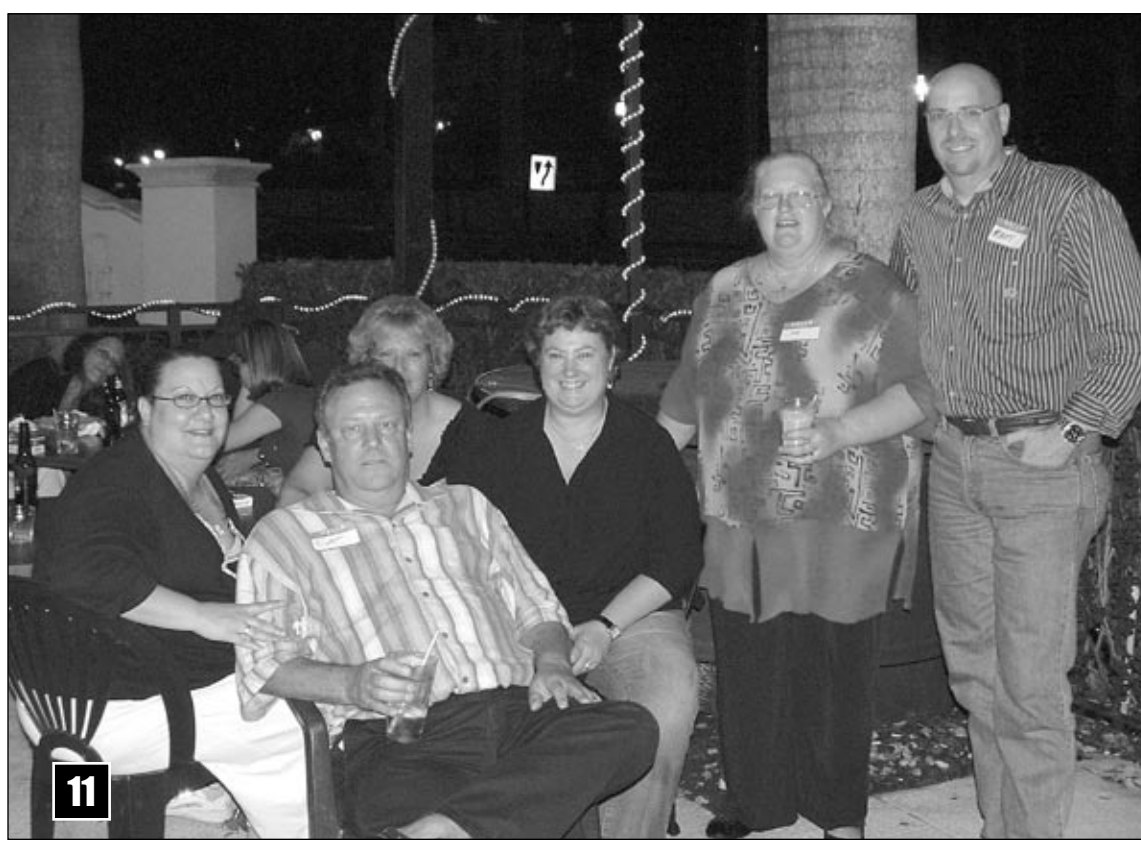

Don't let 'sniffers' nose around proprietary software

Dear Mr. Berko:

I have a proprietary stock market formula that uses various unit trusts to generate long-term gains and or income for my clients. I've only been in this business for five years but my record is very good. I purchase unit trusts with zero commission costs and specific stock market objectives to match the investment of my clients. Each account will own six to eight unit-trusts with maturities of at least 12 months. I charge 1.25 percent a year and have \$54.6 million under management. My clients are low-risk investors. They are happy because the risks are low and the results are very good and I'm happy because I have a "Magic Bullet" (that's what my wife calls it) that hits the target my clients give me. Now my manager told me that we are going to be visited by a New York Stock Exchange auditor (he calls them "pretty boys") next month and that they will want me to show them how my system works, explain how I select the specific unit trust objectives and how I determine what percentage of a client's portfolio is invested in each category. I don't want to disclose my formula. I perfected it over five years and it belongs to me. It's proprietary and if I disclose the methods, then anyone can use it and I have nothing unique to present to clients. My manager is no help and tells me that I have to provide it to them if they ask for it. I know you've been around a long time and I would appreciate any advice or help you can give me.

Dear Concerned in Illinois:

Settle down. I've been in this business before you were in knickers, going on 45 years to be exact, and watched a lot of water flow over the dam. And I've met dozens of "sniffers" (that's what veterans in this business call them) who visit the branch offices of Merrill Lynch, Dean Witter, Prudential, Oppenheimer, etc. However, most sniffers wouldn't know a blue chip from a buffalo chip; think that Moody's is a Bible study course and the 30 Industrials is a new NFL franchise team. Their visit to your office may be the first time they've left home on their own.

They're not bright lads and don't have to be because they are hired to count things and make sure that the cleaning crew isn't pilfering the petty cash. Sniffers count rolls of toilet paper, copy

machine usage plus incoming and outgoing phone calls. They check filing cabinets for rust deposits and secretly film the maintenance people to catch security violations. Then they scoot around the office with puppy dog enthusiasm hoping a secretary will invite them home for dinner. Sniffers are not the sharpest tools in the shed and most have passed the Dale Carnegie personality course ... so they're usually friendly lads. But when they interview you to discuss your accounts, be sincere, even if you don't mean it. And always call them "sir" and respond with a "Yes, sir" or "No, sir." They love to be called "sir."

However, you do not have to disclose your proprietary methods with a sniffer or the New York Stock Exchange. Neither a sniffer nor the exchange has the right to your data. And if they request disclosure, then you have the right to ask for "specific authority," which is similar to a warrant. In that case, you have time to prepare pages of mysterious gobbledygook with colored graphs, statistical probabilities, projections, pictures and give it some fancy title. But not to worry: according to recent autopsies, the brains of most sniffers are sculpted from moldy cottage cheese and can't discern fact from fiction.

I'm familiar with your unit trust concept and it's a swell way to use the power of diversification, various management techniques, measured risk control, diverse category selection and sector timing in a managed portfolio to generate appreciation and/or income. We have a close acquaintance who uses his proprietary construct to purchase unit trusts for managed accounts and his record is similar to yours. We are impressed with its simplicity, its success and low cost and from time to time, under our banner, we employ his expertise in managing some of our accounts. But more importantly, he, too, was asked to divulge his proprietary methods a few years ago. And because this is a family paper I can not repeat the manner of his refusal. Needless to say, he's never been asked again. So hold your water and if a sniffer gets up close and personal, have him call me.



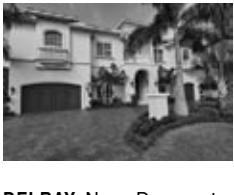

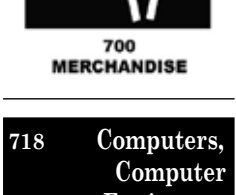

End of the Culpepper era in Miami

The news that the Kansas City Chiefs and Miami Dolphins had finally completed a trade that sent quarterback Trent Green to Miami for a fifth-round pick likely spells the end of the Daunte Culpepper era after one short year.

If Culpepper is released as is expected, he will be known as the biggest failure in Nick Saban's brief tenure (besides Saban bolting for college after insisting he was staying in Miami.)

So what did the Dolphins get for their investment of a second-round pick? A season in which Culpepper was rushed into game action before he was ready, bore little resemblance to the Pro Bowl quarterback he once had been and then was shelved for the year after undergoing another procedure on his injured knee.

But is this the right move for the Fins?

It's clear that from the beginning, Culpepper was never going to be a Cam Cameron's choice as a quarterback.

The long protracted dalliance with Green proved that, as did Cameron's selection of John Beck in the second round of this year's NFL Draft — not to mention the re-signing of Cleo Lemon.

Cameron, who by all accounts is a quarterback guru, never liked Culpepper for his system.

Perhaps he believes that Culpepper isn't the best decision-maker at the position, and perhaps he was scared away by all the mistakes Culpepper makes while trying to make the big play (16 turnovers in his last 11 games over two seasons).

But why give up on one of the game's most talented quarterbacks now? Culpepper hasn't played a down for Cameron yet, and he already seems to be headed out the door before he has shown he is fully recovered from his injury.

Isn't this the same hasty decision-making that has hurt Miami with quarterbacks in the past? Remember A.J. Feeley for a second-round pick, or how about Saban famously going with Culpepper over Brees last year?

Won't Cameron be doing exactly what Saban did last year in his ill-fated attempt to move the franchise forward?

Shouldn't Culpepper at least be given an opportunity to work in Cameron's system and play a few games before he's tossed onto the NFL scrap heap?

Remember, this was a man who only three years ago threw for 39 touchdowns and just 11
