# Mizner Park leaseholder suing Nikolits for 'overassessment'

A dispute over the value of Boca Raton's Mizner Park is going to court.

General Growth Properties and the Boca Raton Community Redevelopment Agency (CRA) have filed suit against Property Appraiser Gary Nikolits, accusing him of using "different appraisal practices" to set a value for the office-retail-residential shopping center near downtown Boca Raton.

It's not the first time Nikolits has been called on the carpet for using the so-called "highest and best use standard" for appraising property. And it's not the first time he's been sued, he

told the *Boca Raton News*.

"Highest and best use is one of eight criteria considered for appraising property," Nikolits

In particular, the appraiser has had to answer local governments and private property owners for using the "highest and best use" test for property being used for a lesser purpose.

Too high?

General Growth Properties – which filed suit under the name Crocker Mizner Park, the original lessee – "disputes the value of the property" set by Nikolits -- \$44 million.

His response? "No, we don't believe we made a mistake." Jorge Camejo, development

services director in Boca Raton and executive director of the CRA, said GGP has a right to dispute the assessment and pursue any remedy regarding

As to the CRA's participation, he said the city is on the lawsuit "in name only. We are the owners of record.'

Basically, Boca Raton owns all the land that makes up Mizner Park. The center was created nearly 20 years ago by the city working with Tom Crocker, who was the original lessee. GGP is the current leaseholder and management company for Mizner Park.

Camejo said GGP "has a 99year lease. That's almost the same as owning."

As to the city's participation, Camejo said it may not be Palm Beach County." much. "We are strictly the owners," he said. The CRA director said he was called to testify in a similar case about 15 years

In the suit filed by Berman, Rennert, Vogel and Mandler, P.A., of Miami, the leasehold said Nikolits' assessment of the Mizner Park property "was arbitrarily based on appraisal practices which are different from the appraisal practices generally applied by the property ap-

praiser to comparable property within the same class within

The suit says Nikolits assessment of \$44 million "is in excess of the just value of the property. The suit adds that Nikolits "failed and refused to consider all the factors set forth" in the applicable state statutes.

But the appraiser told the Boca Raton News that the questioning of his methods hasn't happened lately. "That came up last year regarding some property on the Intracoastal," he said. "The legislature questioned it, then they left it alone. Apparently, nothing is

ast month I talked about a recent federal appeals court ✓ decision that highlights a potentially treacherous problem: the possibility that an employee handbook creates terms that violates the National Labor Relations Act (NLRA) – (Cintas Corp. v NLRB, 2007 U.S. App. Lexis 6075 (D.C. Cir. Mar. 16, 2007).

In light of this decision, employers - even non-union employers - should review confidentiality and communication policies, in handbooks and/or employment agreements, and determine whether employees could reasonably construe such policies to restrict them in discussion of wages or other terms and conditions of employment with other employees (or union representatives). If so, employers should consider revising them as soon as possible and, in doing so, should be guided by the court's admonition that "[a] more narrowly tailored rule that does not interfere with protected employee activity would be sufficient to accomplish the Company's presumed interest in protecting confidentiality."

Accordingly, employers should consider taking one or more of the following steps in revising policies. Define confidential information as narrowly as possible with respect to information about employees (e.g., wages). Avoid sweeping and broad definitions of confidential information that include "all information regarding employees" or "all information

Narrowly define those individuals to whom confidential information may not be disclosed. For example, provide that employees may not disclose confidential information to any competitors of the company or to any other employers upon leaving employment with the company.

Add a "savings" clause, which makes clear that the confidentiality provision is not meant to restrict employees' Section 7 rights, such as, "This policy is not intended, and should not be construed, to limit or prevent an employee from exercising rights under the National Labor Rela-

Of course, after revising policies, employers must ensure that such policies are distributed and/ or communicated to all employ-

# Violence costs us \$70 billion

The most comprehensive study of its kind has found that violence costs the United States \$70 billion annually, a figure that rivals federal education spending and the damage caused by hurricane

Phaedra Corso, lead author of study and associate professor of health policy at the University of Georgia College of Public Health and health economist at the Centers for Disease Control and Prevention, said the study illustrates how much money can be saved by investing in programs that decrease interpersonal violence and self-inflicted violence such as suicide. For comparison, the federal Department of Education has an annual budget of \$67.2 billion and hurricane Katrina caused an

# Boca police charge local man with second-degree murder

Boca Raton police have charged a local resident with murdering a man whose body was found by a jogger Saturday in a wooded area of the 550 block of Camino Real Boulevard.

A police report said Raymond Roach, 36, who lives on NW 13th Street in Boca Raton, was charged Monday with second-degree murder in the beating death of Carlos Rafael Reyes, 53, of 1000 NW Second Ave., Boca Raton.

According to the police report, Roach told police he had been drinking with Reyes and another man when he and Reyes allegedly became involved in an argument.

The report says Roach got angry and began to punch Reyes in the face and chest area.

"Based upon information received during a canvass of the area and the review of recent policy activity, detectives immediately identified Roach as a person of interest in this case," said Sgt. Jeff Kelly, public information officer for the police department.

# Science scores lower some school grades; others maintain A marks

Some Boca Raton principals recently rejoiced; others were not celebrating.

All had just seen this year's school grades.

And while most Boca schools joined the School District itself in maintaining an A status, some schools dropped a grade or a few points from last year's score, including:

- West Boca Raton High School dropped from an A grade last year to a B this year.
- Atlantic High School in Delray Beach dropped from a B to a C school grade.
- Olympic Heights High School in Boca Raton maintained a B status but was a few points farther from an A this year.

Most area school administrators agreed that this year's science portion- the first year it has been counted towards a school's grade- played a major factor in the points drop. Other new components added to the school grade calculation were: learning gains in mathematics among the lowest-performing students, and passing scores for 11th and 12th graders retaking the Grade 10 reading and mathematics FCAT exams.

"That was a tough test. I'm glad we got through it," said Geoff McKee, principal of Boca Raton Community High School, which received an A grade for the third year in a row. "Doing well in science is a huge challenge. It's a difficult test and a relatively new test, and there's not a lot of incentive since it is not a graduation requirement."

Pete Licata, principal of Olympic Heights High School in Boca Raton, said the science portion could have kept the school away from an A grade. Olympic Heights received a B the second year in a

"We were 7 points away from an A," Licata said. "Science is an unknown entity and is not required for kids to graduate so there may have been apathy there as well. There are new rules to the game. We have to go ahead and look at them and see where we're going to get the best plan of action.'

# District-wide

District-wide, the majority of county schools faired well making the School District of Palm Beach County an A district and for the third year in a row. This makes



the district the only large urban district in the state to achieve this distinction. Additionally, the district had a higher percentage of schools receiving a grade of "A" by 63 percent than the state's score of 52 percent.

"The Board Members and I are proud of the success of our students, teachers and school administrators. We have no doubt that our continued hard work will be rewarded with success," said Superintendent Art Johnson.

However, some county school grades declined with three county schools- none in Boca Raton- receiving F grades.

Statewide, Education Commissioner Jeanine Blomberg announced that more than twothirds of all graded public schools received "A" or "B" grades in this year's grading calculation.

"As we focus on meeting the educational needs of our students, we will continue to do all that we can to ensure that all of our students are achieving to the best of ability. I am confident that our schools will rise to the challenge of higher standards as we persist in improving Florida's schools," said Commissioner Blomberg.

Despite high marks and increased scores, some education officials still question the validity of scoring the FCAT after a miscalculation in last year's third grade reading FCAT scores- those scores were not included in calculating this year's school grades.

# **Moving Forward**

Boca principals said they are already looking forward thinking of ways to improve next year's

"Kids will take the science portion more seriously next year. We're excited about next year, and we're going to nail an A next year," Licata said.

# Wlotko promoted to operations senior VP at Patriot

Formed late in 2006, Patriot Rail Corp., a Boca Raton based short line and regional railroad holding company, has purchased two short-line railroads since formation – and this week announced the promotion of Stanley Wlotko to senior vice president operations.

Wlotko, 56, has over 34 years of railroad industry experience and has held senior management positions in purchasing, rail operations, marketing, project management and outsourced services, said Patriot Chairman, President and CEO Gary O. Marino. Since

joining Patriot Rail shortly after its formation, Wlotko has been responsible for the management of the company's railroad operations and business development, Mario

"Since the acquisition of our first railroad last year, Stan has been an integral part of the Patriot Rail management team and has done a tremendous job managing our railroads," said Marino, add-

"At our Tennessee Southern Railroad, he has worked with the railroad's personnel, as well as state and local economic development groups, to grow the business considerably, as reflected by the 53 percent increase in carloads in our first six months of ownership. Stan has also successfully integrated the operations of our recently-acquired Rarus Railway in Montana and is currently seeking to expand business beyond its existing customer base."

During his career, Wlotko has worked for several railroads, including Penn Central, Conrail, Denver & Rio Grande, Southern Pacific, Union Pacific and RailAmerica. He received a B.A. in Business Administration from St. Joseph's University and is an active member of the Association of Railroad Superintendents.

Patriot Rail Corp currently owns and operates two short line freight railroads comprising 212 total rail miles – the Tennessee Southern Railroad in Tennessee and the Rarus Railway in Montana.

Following the November 2006 Tennessee Southern acquisition, Rarus Railway Corp., a short line railroad headquartered in Anaconda, Montana, was Patriot's second purchase since the firm was formed. "And our intention over the next several years is to make a series of additional rail acquisitions," said Marino.

"Together with our new capital partner, we have an ambitious strategic plan to make a number of select rail acquisitions throughout North America over the coming years. It is our desire to become a preeminent rail freight transportation provider, capitalizing on the resurgence of rail transportation across the continent. Our goal is to provide shippers with unique, affordable solutions to transportation needs. Putting the movement of bulk commodities back onto the rail system is far more economical than road transportation, while also alleviating the road congestion caused by heavy trucks."

Marino is the former chairman, president and CEO of Rail-America, Inc., also based in Boca Raton -- and which late last year announced it's \$1.1 billion merger with an affiliate of Fortress Investment Group LLC.

Marino was a co-founder of RailAmerica in 1992 with his brother John H. Marino. Until March 2004, he was also the company's chairman. Under his tenure RailAmerica grew from a private company owning one railroad, to a New York Stock Exchange listed company owning 47 railroads with revenue of about \$360 million.

He retired from RailAmerica in April 2004.

# Boca says Spanish River Library to make debut in January

Around the time the ball drops in Times Square heralding the start of 2008, the library on Spanish River Boulevard in Boca Raton will be opening its doors to the public.

That's the latest timetable from the city of Boca Raton, which is still reveling in the fact that construction has begun after a hiatus of more than a year.

The original contractor sued the city, allegedly for withholding payments and failure to grant extensions. That was in March 2006. A few months ago, the city hired Kaufman Lynn to finish the job.

Assistant City Manager Mike Woika said construction "seems to be going well," and the Jan. 1 opening date seems to be on track. Mike Lynn, owner of the development company, said the building may be done sooner, but it has to be furnished.

Little by little, the city has been doing that. The City Council recently purchased \$1.2 million worth of furnishings for the structure. Woika said that includes tables, chairs and book stacks. The city has already bought computers.

# Number 1 question

When he toured the facility in May, Mayor Steven Abrams said

the Number 1 question he receives from residents in the community is, "When will the Spanish River Library be completed?"

When finished, it will have a café, two terraces, computer lab and story area for children, among other things. A teen meeting room is also planned.

The library faces Spanish River Boulevard. The rear affords a view of Blue Lake through some twostory cathedral-type windows.

While the community's attention seems focused on the Spanish River Boulevard Library – which will be part of de Hoernle Park — the city is also reviewing the site on NW Second Avenue where a new downtown library is to be constructed.

# **Downtown library**

That library, Woika said, is in the pre-design phase. Its future may be a little cloudy, depending on how tax reform impacts the city. Right now, City Manager Leif Ahnell said

the budget for fiscal 2007-2008 will be \$4.5 to \$5.5 million less than the current year.

Woika said the city is revisiting all its capital projects. "We are not jumping in until we see what's available."

The new downtown library is to be built a few blocks north of the existing facility. The new building will be adjacent to a development of

# Motorola: The big engine that can't keep running

Dear Mr. Berko:

I have owned several Motorola phones and I'm pleased with how they work. I would like to invest \$1,000 for my son, who also owns a Motorola cell phone, and buy him 50 shares of Motorola stock, which sells for less than \$20. Do you think this would be a good, long-term purchase for him?

P.N. Aurora, Ill.

Dear P.N.:

It's almost inconceivable that back in early 2000, Motorola Inc. (MOT-\$18.71) was trading at \$180 a share then split 3-for-1. MOT's revenues in 2000 were \$37 billion and this year MOT believes it will post \$42 billion in revenues. That's wondrously unimpressive.

In 2000, MOT's free cash flow was \$1.94, it earned 90 cents a share, book value was \$8.94 and net profit margins were 5.9 percent. This year, MOT's free cash flow might be 85 cents, earnings could reach 50 cents, book value will probably fall to \$6.50 while net profit margins may collapse to 2.6 percent. That's roundly underwhelming!

Most folks know that MOT designs, manufactures, sells and services cell phones, accessory products and licenses intellectual products to carriers. Most of us also know that MOT is a powerful player in the network and enterprise markets.

In the past few years, MOT has become a textbook example of incompetent management. Chief Executive Officer Ed Zander was paid \$5 million plus perks to visit his office a few days each week and have rugelach and coffee with his toadies. MOT is also a textbook example of a quintessential rubber-stamp board of directors, each of whom ought to be publicly pilloried for allowing incompetent CIBC World Markets, Deutsche

and sophomoric management to run the company. One prime directive of a corporate board is to patrol the company in the best interest of shareholders. MOT's hugely paid but inutile puppets and pawns miserably failed shareholders.

Meanwhile, Zander would play golf at a private, prissy Chicago country clubs rather than run a \$40 billion company. MOT's board prefers to party rather than perform elected duties. Zander publicly admitted that laziness and mistakes have crippled the stock and faults his board for refusing to adopt 3G technology while the competition was gobbling market share in the U.S. and abroad. Why MOT's stockholders blithely accept this malfeasance is an enigma to me.

With falling revenues and earnings, Zander and his pigeons on the board approved a massive stock repurchase program and will lay off 5 percent of the work force to reduce costs. That's really bloody stupid because neither will improve revenues or net profit margins.

Zander and his sycophantic board need to hire creative research and development people to create exciting, new products. Zander and his apple-polishers must hire inspired marketing people with vision to improve revenues. Finally, Zander and his pawns must find professionals who can bring efficiency to MOT's development, production and distribution process. Failing that, MOT might as well fold its tent and steal away.

Because I doubt that Zander and his board have the capability to accomplish those goals, I would not want to own the stock. And this seems to be the prevailing opinion on Wall Street. So far in 2007, Bear Stearns, Oppenheimer,

Securities, Jeffries, Lehman Bros., Charter Equities, Value Line, BMO Capital Markets, Goldman Sachs and RBC Capital Markets have all downgraded Motorola. In fact, there's not one "buy" recommendation among the 11 analysts.

# Musician sings to Boca residents in more than 15 languages

"This is one of my favorite songs on the CD," beamed Claude Kadoch, pointing to the song Yael.

The local musician's accent softened as his tone turned somber, "It's about love, a father's love for his daughter," he said, pausing for a moment then continuing, "His daughter was sick with chromes disease and he wrote a song for her and I recorded it. I wanted to do something for her. I wanted to help her heal." Yael, also the title of the CD, was sung in Hebrew and named after his friend's daughter, who is now healthy.

Pulling out another CD, but this one, multi-colored, vibrant and titled "Miami Storm," Kadoch perks up. "This is all about Miami. It's jazz and rock flamenco and all instrumental," he said.

Kadoch pulls out two more CD's pointing to various tracks with much energy and enthusiasm. He then takes out a pile of photographs. He continues, "This is one of me and Al Gore." In the next breath, "This is me at 17 when I really started playing the guitar."

Kadoch recounts life-long memories of performing as a musician in various countries in front of large, cheering crowds. But those memories are not over. Neither is his performing but cultural experiences have added to his music.

Kadoch can sing in over 15 languages. Among the most popular are English, Italian, French, Spanish, Greek, Hebrew and Yiddish.

"I first started singing in English and Hebrew but I got influenced with different languages while playing in Europe. I've been to Italy, France, and Spain doing tours and learn through every country," said Kadoch, who's from Casablanca, Morocco.

# **Cultural Music**

As a teenager surrounded by a musically-inclined family, Kadoch took an

interest in instruments and began playing the trumpet, then the drums, after bass and finally composing music. Later, he studied the piano at the conservatory of music in Israel. He went on to play in various bands and tour across the na-

"I was part of the first trio in Israel and we went overseas," said Kadoch, continuing, "Then I played the guitar and sang for a Greek singer that became very popular in Israel and made a lot of CDs.'

Once he moved to Florida some 20 vears ago, Kadoch started an electronics and jewelry business. But missing music, he left that business and started Claudio Productions, singing at local venues, weddings, concerts, anniversaries, private parties, corporate functions, and events. "Let's Go Party with Claudio" is the theme and Kadoch says he will customize music to the client's needs- singing in whatever language they choose with original and cover songs. Many times, he brings an act called "Claude & Andrea: Dynamic International Duo." Andrea Farfan plays the saxophone, clarinet, dances and sings in English, Hebrew, and Spanish.

"I mix it up, but if they want a particular language, I do what they want. If they want more Italian, I play more Italian," he said.

Kadoch said one of his favorite venues is in Boca Raton at Mizner Park among many others.

"People in Boca love flamenco style and I play this kind of music and I play my own style but also with different artists and composers," he said.

And after more than 25 years of singing in various languages, Kadoch says one thing remains the same, "I play for them to be happy and make life happy for them."

Projections have shown that implementation of cardiovascular disease secondary prevention guidelines nationwide, as promoted in the GWTG-CAD program, could result in saving more than 80,000 lives each year.

To receive the award, West Boca Medical Center consistently complied for 12 months with the requirements of the GWTG-CAD program. Under the program, patients are started on aggressive risk reduction therapies such as cholesterol-lowering drugs, aspirin, ACE inhibitors and beta-blockers in the hospital and receive smoking cessation and weight management counseling and referrals for cardiac rehabilitation before they are discharged.

Hospitals receiving the award have demonstrated that during

12 consecutive months at least 85 percent of its eligible coronary patients (without contraindications) are discharged following the American Heart Association's recommended treatments.

# Can you have too much of a good thing?

It's totally understandable to feel ambivalent when presented with both positive and negative evidence. However, people often feel ambivalent even when all the news is good or bad, anticipating conflict before it arises. The first empirical demonstration of this reaction appears in new study in the Journal of Consumer Research.

"Many people recognize that there are often two sides to every story and that nothing is perfect (or completely worthless)," explains

Joseph R. Priester (University of Southern California), Richard E. Petty (Ohio State University) and Kiwan Park (Sungkyunkwan University, South Korea). "Thus, even if they are unaware of any negative features of a mostly positive product (or unaware of any positive features of a mostly negative product), they may assume that such features exist."

One important factor in the phenomenon, which the researchers term "anticipated conflicting reactions," is the number of positive or negative pieces of information provided. The researchers found that the more information consumers are given, the less likely they are to suspect the existence of conflicting information of which they are unaware.

"At the most basic, this paper advances and finds support for a new construct, the anticipation of conflicting reactions. Importantly, this construct helps to explain why univalent attitudes sometimes are associated with ambivalence," the

# Selling equity turns 'your' company into 'our' company

If you have been following my column for the last month you should be very familiar with all of the ways to raise capital via loans also known as debt.

This week I am changing gears and beginning to discuss what most entrepreneurs are seeking more than any good loan...equity. Equity simply means ownership in something and for our purposes, raising capital by selling ownership in your business.

Many business owners looking for business capital are always more open minded to fund their businesses by giving up some ownership in the company in return for the capital necessary to start, grow or expand their business. I wish I had a dollar for every time I overheard a conversation around town where one person was saying to the other, do you know someone who would like to invest into my company?

## **Pros** and cons

Raising capital through the form of selling equity is very popular but just like its sibling, debt, it has its pros and cons. When most of us think of equity we think of angel investors, venture capitalist and/or silent partners. These types of individuals are the most common equity players. They are plentiful in numbers and always looking for a new deal to put some fresh capital into. But the fact is that there are more deals around then investors, so it is always an investor's market. Moreover, not all deals are the same so the quality deals usually rise to the top and get the greatest attention.

The most attractive reason why we love equity capital is because it does not require an immediate structured pay back like debt. With debt service we have a set schedule to begin paying back the money we borrowed along with some interest. Debt is also quite often secured by some if not all of the assets of the business.

## Goes to company

Equity on the other hand is most often just the opposite. The money received for the equity is contributed to the company in return for stock in the company and there is no collateral required when issuing stock. The idea of giving up some ownership in exchange for the business capital you need without the liability of paying it back sounds and is very attractive.

Equity does have its issues to think about. Equity contributions by venture capitalists or angel investors often come with strings attached.

First and paramount to these equity investors is a voice in the company's operations and some ability to be involved in the decision making of the company. Most equity deals come with such requirements such as obtaining one or more board positions and having the power to exercise voting rights especially when it pertains to material business de-

As to repayment, most equity deals require the equity partner to receive the money back before anyone else receives any personal loans on the business or distributions.

# Main issue

The main issue I often counsel my clients to think about is whether or not they are ready and prepared to have a business partner. Equity financing turns "your" business into "our" busi-

ness. Equity partners are in fact, co-owners. Most often, they have all of the rights that you, the business owner, have when it comes to ownership and profits. They can request to see your books and records, they can question certain operational decisions and most often they can become a daily analyst and overseer of all of the business activities.

It is possible to limit the rights of your equity investor; however, today's equity investors are looking for some protection and are not just walking away from their

A major positive benefit is that a large amount of equity investors are former entrepreneurs themselves and have much to contribute along with their money. Many of them have started, managed and sold very successful businesses and can give you the real moral support, encouragement and business advice you may need to strengthen and grow your

Equity investment can be a real benefit for both the business owner and the equity investor when a good deal is structured as a winwin for both.







# Schulz has big plans for academy, area soccer

The Schulz Academy has elevated its profile steadily over the last few years, and Director Josef Schulz wants to take the soccer program to even greater heights in the future.

Schulz recently formed a partnership with a second division club in Cameroon, America for Africa FC. Schulz represented more than 100 professional players as an agent prior to coming to the United States, and he is looking to develop and market African players as they continue to develop into major talents in the sport of soccer.

"The talent is probably the best in the world," Schulz said. "The physical talent they have and the mental abilities are enormous."

Schulz will travel to Cameroon in November to host a camp for hundreds of American players, and he will go on a scouting tour for talent.

Schulz has also formed an alliance with two Brazilian clubs, and he is working on forming another one with an Argentine school that represents four clubs in that country.

Locally, Schulz is also working hard to form alliances. He has already made deals with the Palm Beach Kicks and club teams in Miramar and Coral Springs. Schulz would like to include Team Boca in the alliance as well, but he has not yet contacted them about the

possibility as he has been heavily involved in the other deals.

To Schulz, forming these alliances in the local area is critical to the future of the sport, as well as the future of developing players.

"If you see the Chicago Magic, that city has maybe five million people and one big club to represent them," he said. "Little Mickey Mouse Boca Raton has three clubs and 15 in the surrounding areas. How can this (city) be a powerhouse?"

The clubs would still be independent, but according to Schulz's plan, they would all work together to form what he calls the Elite Soccer Alliance, with the Schulz Academy as the foundation.

The academy can offer travel clubs and competition in prestigious national leagues like the Super-Y.

"The idea is to have every player play in the environment he belongs in," Schulz said. "If you're a top player, playing with players who are not so good hurts your development. And if you're not a good player, why would you play with the top players?"

Schulz believes getting the best players to play together at the same level is the next step to American dominance in soccer.

Schulz gives the plan two years to see the first fruits of labor, but without the alliance, the academy

has proven itself adept at developing national talent.

Former Schulz player Josmer Altidore is now in the MLS and at the moment is competing for the United States U-20 team in the World Championships in Canada.

A younger player, Donovan Henry, has also excelled at the international level. Playing for the U15 National Team in Spain and Argentina, Henry scored goals against fabled Argentine club Boca Juniors and against the Argentina National Team.


"He's one of the fastest players I've ever seen," Schulz said. "He combines speed with the necessary technique, which you don't always find in a player. He's either fast or has technique, but to have both is very rare."

As for the Schulz Academy teams, they are faring well in the Super-Y League this year, combining for a 22-3-2 record in the five age groups.

Schulz is hoping all five will qualify for the national finals in November in Tampa, as they did last year when Schulz was the only soccer program to accomplish the

And his hopes for the next five years are even higher for the academy.

"We will be the No. 1 soccer entity in this country, with not only training players but placing them at the professional level," Schulz



The most successful product of the Schulz Academy so far has been Josmer Altidore, who is playing for the U-20 United States National Team in the World Championships in Canada. Schulz is hoping to add more names to the list by forming alliances with club teams in Boca Raton and with clubs in other countries.
